The following information describes vaccine compliance rules as defined by the Rhode Island Department of Health.

#### **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days earlier than the minimum interval or age are not considered valid doses and must be repeated as age-appropriate.

#### **DTap DTP**

Rule	Requirements
0-2 months No requirement	Students age 0-2 months old are not required to receive any doses of the DT, Tdap, Td, or DTaP-DTP vaccine.



Rule	Requirements
3-4 months Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 3 months, but no older than 4 months old, and</li> <li>the student receives one dose of the DT, Tdap, Td, or DTaP-DTP vaccine.</li> </ul>
5-6 months Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 5 months, but no older than 6 months old, and</li> <li>the student receives two doses of the DT, Tdap, Td, or DTaP-DTP vaccine.</li> </ul>
7-18 months Compliant	Students are considered compliant if the following conditions have been met:  • the student is at least 7 months, but no older than 18 months old, and  • the student receives three doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
19 months and older Compliant	Students are considered compliant if the following conditions have been met:  • the student is at least 19 months old, and  • the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
5 doses Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and</li> <li>the student receives five doses of the DT, Tdap, Td, or DTaP-DTP vaccine.</li> </ul>
4th dose after 4yrs Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine,</li> <li>the difference between the first dose and the student's birthdate is less than 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 4 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>

# **Tdap**

Rule	Requirements
1 dose Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>student is in state grade 07, 08, 09, 10, 11, 12, and</li> <li>the student receives 1 dose of the Tdap vaccine.</li> </ul>



Rule	Requirements
No Doses Non- compliant	Students in state grade 07, 08, 09, 10, 11, 12, who have not received any doses of the Tdap vaccine are non-compliant.

# **Hepatitis B**

Rule	Requirements
<b>0-2 Months</b> <i>No Requirement</i>	Students age 0-2 months old are not required to receive any doses of the Hepatitis B vaccine.
<b>3-4 Months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met:  • the student is at least 3 months, but no older than 4 months old, and  • the student receives one dose of the Hepatitis B vaccine.
5-18 Months Compliant	Students are considered compliant if the following conditions have been met:  • the student is at least 5 months, but no older than 18 months old, and • the student receives two doses of the Hepatitis B vaccine.
19 months and older Compliant	Students are considered compliant if the following conditions have been met:  • the student is at least 19 months old, and  • the student receives three doses of the Hepatitis B vaccine.

## **Polio**

Rule	Requirements
<b>0-2 months</b> <i>No Requirement</i>	Students age 0-2 months old are not required to receive any doses of the IPV, OPV, or IPV-OPV Polio vaccine.
3-4 months Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 3 months, but no older than 4 months old, and</li> <li>the student receives one dose of the IPV, OPV, or IPV-OPV Polio vaccine.</li> </ul>
5-18 months Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 5 months, but no older than 18 months old, and</li> <li>the student receives two doses of the IPV, OPV, or IPV-OPV Polio vaccine.</li> </ul>

18 yrs and older No Requirement	Students age 216 months (18 years) old and older are not required to receive any doses of the IPV, OPV, or IPV-OPV Polio vaccine.
