## **Object Triggering Logic**

This table describes logic for triggering syncing of this object.

Action	Trigger			
Post	<ul> <li>When a new blended learning group is created and the status is set to Active and at least one student is assigned to the Blended Learning Group: <ul> <li>A separate record is sent for each school where there is at least one student added to the group based on the school of the student's enrollment.</li> <li>Does not send a record when the Blended Learning Group is only assigned to students with enrollments in a calendar and/or school that is marked exclude.</li> </ul> </li> </ul>			
Post	<ul> <li>When a new Rule 18 program and student transcript record are created in the calendar's configuration year.</li> <li>The Rule 18 program must overlap the calendar's configuration year.</li> <li>The student must have a transcript record with the Teacher Number field populated where the record overlaps the calendar's configuration year. See the Nebraska Rule 18 Interim-Program School Program Reporting article for additional information.</li> <li>Does not send when the the Rule 18 Program is assigned to a student with an enrollment in a calendar and/or school marked as Exclude.</li> </ul>			
Put	Updates modalityTypeDescriptor when a Blended Learning Group is either assigned to a calendar day or removed from all calendar days in a school.			
Put	Recalculates modalityTime whenever a Blended Learning Group is either added or removed on the Calendar Days.			
Delete	<ul> <li>When the Blended Learning Group is marked as Archived.</li> <li>When the enrollment is marked State Exclude or No Show.</li> <li>When the enrollment determining the record is deleted.</li> <li>When part of the record's Natural Key changes.</li> <li>When a Rule 18 Program is deleted or when the record no longer overlaps the configured year.</li> </ul>			

#### **Resource Toggle/Resync**

Action	Business Rule				
None	When a resource is toggled to OFF after data has sent, all sent data remains in the ODS but no new data sends.				
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.				
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.				
Resync	When a mapping is changed in Resource Preferences, a resync is needed to reflect the changes.				



#### Natural Key Changes, Cascading Updates, Deletes

Action	Business Rule				
Post/Delete	Natural Key changes.				
	LEA Reference - District Numbers cannot change after data has been sent. When a district number changes, an Ed-Fi error is expected and this change is not supported.				
	When an Ed-Fi ID changes, a delete/post occurs with the cascading deletes from the Ed-Fi ID Change triggers.				
	When the Program Name or Program Type Descriptor mapping changes and a resync is completed.				
	When the Flag Start Date or Flag Name changes, all Student Program Associations is deleted and then reposted.				
Delete	Cascading Deletes: N/A - no dependent resources

The record will send to the scope year for the school year the program association record is associated with.

Data will only send for the years that have valid configuration.
