Action	Trigger
Post	When an IEP is created and locked and overlaps the configured year and the student has an enrollment in the configured year.  or  The student has a State Reporting SPED record that overlaps the configured year and the student has an enrollment in the configured year.  • Do not send a record if enrollment is in a calendar marked as Exclude.  • Do not send a record if enrollment is in a school marked as Exclude.  • The Print Format of the IEP can be either the Campus Default IEP or a State IEP.  • Do not send a record if enrollment is marked as No Show.
