| Action | Trigger |
|-------------|--|
| Post | When an IEP is created and locked and overlaps the configured year and the student has an enrollment in the configured year. or The student has a State Reporting SPED record that overlaps the configured year and the student has an enrollment in the configured year. <ul style="list-style-type: none"> Do not send a record if enrollment is in a calendar marked as Exclude.
