

Tool Search: Student Residence

The SR report extracts one physical address per student for every student who was actively enrolled on the date on which the report is generated. The purpose of this report is to determine the location of families for additional funding in the state of Indiana.

To report, each student MUST have a physical address. Students that only have a PO Box address in Campus are not included in the report.





Example Student Residence Report Editor

Report Logic

- Reports one physical address per student for every student who was actively enrolled on the date on which the report is generated.
- If a student has more than one physical address, the Primary address reports.
- If a student has more than one address marked as primary, the first address entered reports.
- If a student has multiple enrollments that overlap the effective date of this report, the school based on the latest enrollment reports.
- Students in all grades PK 13 report.
- · Students are NOT included if
 - they ONLY have a PO Box address in Campus.
 - their enrollment ended the day prior to the Effective Date on this report.
 - their enrollment starts the day after the Effective Date on this report.
 - their enrollment record is marked as State Exclude.
 - their enrollment record is marked as No Show.
 - their Grade Level of enrollment is marked as State Exclude.
 - o their Calendar of enrollment is marked as State Exclude.
