- Student must have an active enrollment (any enrollment type) that meets all of the following requirements.
  - Enrollment is in a calendar selected in extract editor.
  - Enrollment is tied to a state grade between 04 and 12.
  - Student does NOT have an active certificate tracked program as of the report Effective Date.
  - If student has multiple enrollments use the most recent primary enrollment, which meets the previous requirements.
  - If no primary enrollment exists, Campus uses the most recent enrollment which meets the previous requirements.
- Students are NOT included if
  - their enrollment record is marked as State Exclude.
  - their Grade Level of enrollment is marked as State Exclude.
  - their Calendar of enrollment is marked as State Exclude.
