Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Indiana State Department of Health.

As of the 1214 Release Packs (April 2012), vaccine compliancy has been updated to have a Live Vaccine option. The following vaccines have been updated to include the Live Vaccine:

- MMR
- MMRV
- Measles
- Rubella
- Mumps
- Flu
- Varicella

## General Compliance

- Vaccine doses administered less than or equal to four days before the minimum interval or age are counted as valid.
- Doses administered five days earlier than the minimum interval or age are not counted as valid doses and should be repeated as age-appropriate.
- No requirements exist for state grade PW (preschool 0-2 years).

The following tables describe all Indiana immunization requirements per vaccine.

## Hepatitis B

Rule	Requirements
<b>Grade PW</b> <i>No Requirement</i>	Students is state grade: PW: Preschool Ages 0-2 are not required to receive any doses of the Hepatitis B vaccine.
<b>2 doses age 11+</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 132 months (11 years) old, and</li> <li>the student receives two doses of the Hepatitis B - 2 Dose (HepB-2) vaccine.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives three doses of the Hepatitis B vaccine,</li> <li>the difference between the second dose and the first valid dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the last dose and the second valid dose is greater than 56 days with a 4 day tolerance,</li> <li>the difference between the last dose and the first valid dose is greater than 112 days with a 4 day tolerance, and</li> <li>the difference between the last dose and the student's birthdate is greater than 168 days with a 4 day tolerance.</li> </ul>
<b>3rd dose</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Hepatitis B vaccine, and</li> <li>the difference between the last dose and the effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>
<b>3rd dose</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Hepatitis B vaccine, and</li> <li>the difference between the second to last and the effective date is less than 112 days with a 0 (zero) day tolerance.</li> </ul>
<b>2nd dose</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the Hepatitis B vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>2 dose HepB-2</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 132 months (11 years) old,</li> <li>the student receives one dose of the Hepatitis B - 2 Dose (HepB-2) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is less than 3 months with a 1 day tolerance.</li> </ul>

## Hepatitis A

There are no immunization requirements for PK and 3-12 Grade levels.

<b>2 dose</b> <i>Compliant</i> <i>Active End Date:</i> <i>06/30/2020</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 12,</li> <li>the student receives two doses of the Hepatitis A vaccine,</li> <li>the difference between the second dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>2 dose PreK-12 2020-2021</b> <i>Compliant</i> <i>Active Start Date:</i> 07/01/2020	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Hepatitis A vaccine,</li> <li>the difference between the second dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>1 dose</b> <i>In Progress</i> <i>Active End Date:</i> 06/30/2020	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 12,</li> <li>the student receives one dose of the Hepatitis A vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirement
<b>1 dose</b> <i>In Progress</i> <i>Active Start</i> <i>Date: 07/01/2020</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the Hepatitis A vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 1 day tolerance.</li> </ul>
<b>K-7; 12</b> <i>Non-compliant</i> <i>Active End</i> <i>Date: 06/30/2020</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 12, and</li> <li>the student has not received any doses of the Hepatitis A vaccine.</li> </ul>
<b>PreK-12 2020-2021</b> <i>Non-compliant</i> <i>Active Start</i> <i>Date: 07/01/2020</i>	Students are considered non-compliant if the student has not received any doses of the Hepatitis A vaccine.
<b>Default</b> <i>No Requirement</i> <i>Active End</i> <i>Date: 06/30/2020</i>	N/A

## DTaP

Doses of Tdap are also acceptable to fulfill these requirements, except for the 4 dose rule for PK students. There are no requirements for students age 0-1 month.

Rule	Requirements
<b>Age 0-1 months</b> <i>No Requirement</i>	Students age 0-1 month old are not required to receive any doses of the DTaP vaccine.
<b>1 dose Age 2-3 months</b> <i>Compliant</i>	Students are compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old,</li> <li>the student receives one dose of the DT, DTaP, Td, or Tdap vaccine, and</li> <li>the difference between the first dose and student's birthdate greater than 42 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses Age 4-5 months</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 4 months, but no older than 5 months old,</li> <li>the student receives two dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>the difference between the first dose and student's birthdate greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses Age 6-14 months</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 6 months, but no older than 14 months old,</li> <li>the student receives three dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>the difference between the first dose and student's birthdate greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>the difference between the third and the previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>4 doses under 4</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at no older than 47 months old,</li> <li>the student receives four dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>the difference between the first dose and student's birthdate greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>4 doses</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 48 months (4 years) old,</li> <li>the student receives four dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>the difference between the first dose and student's birthdate greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>5 doses</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months (4 years) old,</li> <li>• the student receives four dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>• the difference between the first dose and student's birthdate greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>• the difference between the fifth dose and the previous is greater than 6 months with a 4 day tolerance.</li> </ul>
<b>3 doses 7+</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 84 months (7 years) old,</li> <li>• the student receives three dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>• the difference between the first dose and student's birthdate greater than 12 months with a 4 day tolerance,</li> <li>• the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and the previous dose is greater than 6 months with a 4 day tolerance, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>4 doses 7+</b> <i>Compliant</i>	<p>Students are compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 84 months (7 years) old,</li> <li>the student receives four dose of the DT, DTaP, Td, or Tdap vaccine,</li> <li>the difference between the first dose and student's birthdate less than 11 months with a 4 day tolerance,</li> <li>the difference between the second and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and the previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth and the previous dose is greater than 6 months with a 4 day tolerance,, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>3 doses</b> <i>In Progress</i>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives three dose of the DT, DTaP, Td, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 1 day tolerance.</li> </ul>
<b>2 doses 7+</b> <i>In Progress</i>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 84 months (7 years) old,</li> <li>the student receives two dose of the DT, DTaP, Td, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 1 day tolerance.</li> </ul>
<b>1 dose</b> <i>In Progress</i>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives one dose of the DT, DTaP, Td, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Tdap

One dose is required for state grades 06, 07, 08, 09, 10, 11, 12, given on or after 10 years of age, with a 4 day tolerance.

## Meningococcal

One dose is required for grades 6 and above.

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 06, 07, 08, 09, 10, 11, and</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>2 doses</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 12, and</li> <li>the student receives two doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>1 dose</b> <b>16 yrs</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 12,</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 192 months with a 4 day tolerance.</li> </ul>
<b>Grades 6-12</b> <i>Non-compliant</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 06, 07, 08, 09, 10, 11, 12, and</li> <li>the student hasn't received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>

## MMR

Rule	Requirements
<b>Grade PW</b> <i>No Requirement</i>	Students is state grade: PW: Preschool Ages 0-2 are not required to receive any doses of the MMR or MMRV vaccine.
<b>1MMR</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: PK: Pre-kindergarten,</li> <li>the student receives one dose of the MMR or MMRV vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>



Rule	Requirements
<b>1M, 1M, 1R</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: PK: Pre-kindergarten,</li> <li>the student receives one dose of the Measles vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance OR</li> </ul> </li> <li>the student receives one dose of the Mumps vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>the student receives one dose of the Rubella vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul> </li> </ul>
<b>2MMR</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two dose of the MMR or MMRV vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>2M, 2M, 1R</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two doses of the Measles vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>the student receives two doses of the Mumps vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>the student receives one dose of the Rubella vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul> </li> </ul>

<b>1MMR, 1M, 1M</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the MMR or MMRV vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the student receives one dose of the Measles vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance OR</li> </ul> </li> <li>the student receives one dose of the Mumps vaccine, and <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>the student receives two doses of the Measles, MMR, or MMRV vaccine, and <ul style="list-style-type: none"> <li>the difference second dose and the previous is greater than 28 days with a 4 day tolerance,</li> </ul> </li> <li>the student receives two doses of the Mumps, MMR, or MMRV vaccine, and <ul style="list-style-type: none"> <li>the difference second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul> </li> </ul>
<b>2nd dose</b> <i>In Progress</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives one dose of the Measles, Mumps, Rubella, MMR, or MMRV vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Varicella

Rule	Requirements
<b>Grade PW</b> <i>No Requirement</i>	<p>Students is state grade: PW: Preschool Ages 0-2 are not required to receive any doses of the Varicella vaccine.</p>
<b>1 dose</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: PK: Pre-kindergarten,</li> <li>the student receives one dose of the MMRV or Varicella vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two doses of the MMRV or Varicella vaccine,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>the difference between the last dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

## Polio

Rule	Requirements
<b>Grade PW</b> <i>No Requirement</i>	Students is state grade: PW: Preschool Ages 0-2 are not required to receive any doses of the Polio vaccine.
<b>3 doses PK</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: PK: Pre-kindergarten, and</li> <li>the student receives three doses of the IPV, OPV, or IPV/OPV vaccine.</li> </ul>
<b>4 doses before 2009</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives four doses of the IPV, OPV, or IPV/OPV vaccine,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>the last dose was received before 08/09/2009.</li> </ul>
<b>4 doses</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives four doses of the IPV, OPV, or IPV/OPV vaccine,</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance.</li> </ul>

<b>3 doses IPV</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives four doses of the IPV, or IPV/OPV vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>3 doses OPV</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives four doses of the OPV, or IPV/OPV vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
