## Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	When an IEP is created and locked and overlaps the configured year and the student has an enrollment in the configured year. or The student has a State Reporting SPED record that overlaps the configured year and the student has an enrollment in the configured year. <ul style="list-style-type: none"> <li>Do not send a record if enrollment is in a calendar marked as Exclude.</li> <li>Do not send a record if enrollment is in a school marked as Exclude.</li> <li>The Print Format of the IEP can be either the Campus Default IEP or a State IEP.</li> <li>Do not send a record if enrollment is marked as No Show.</li> </ul>

## Resource Toggle/Resync Logic

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.
