## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- Doses administered 5 days earlier than the minimum interval or age shall not be counted as valid and must be repeated as age appropriate.

<b>4 doses KG-12 Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• the student receives four doses of the DTaP vaccine,</li> <li>• the student receives their first dose on or after 6 weeks of age,</li> <li>• the student receives the fourth dose on or after 4 years of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 4 months.</li> </ul>
<b>3 doses 1-12 Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• the student receives three doses of the DTaP vaccine,</li> <li>• the student receives their first dose on or after 7 years of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>Ages 0-2 months No Requirement</b>	<p>Students 2 months old and younger are not required to receive any doses of the DTaP vaccine.</p>

Rule	Requirements
<b>1 dose 3 - 4 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): PK,</li> <li>• the student is at least 3 months, but no older than 4 months old,</li> <li>• the student receives one dose of the DTaP vaccine, and</li> <li>• the student receives their first dose on or after 6 weeks of age.</li> </ul>
<b>2 doses 5 - 6 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): PK,</li> <li>• the student is at least 5 months, but no older than 6 months old,</li> <li>• the student receives two doses of the DTaP vaccine,</li> <li>• the student receives their first dose on or after 6 weeks of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>3 doses 7 - 18 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): PK,</li> <li>• the student is at least 7 months, but no older than 18 months old,</li> <li>• the student receives three doses of the DTaP vaccine,</li> <li>• the student receives their first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the third and previous dose is greater than or equal to 4 week.</li> </ul>
<b>4 doses 19 months - 6 years</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): PK,</li> <li>• the student is at least 19 months, but no older than 6 years old,</li> <li>• the student receives four doses of the DTaP vaccine,</li> <li>• the student receives their first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 week, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 4 months.</li> </ul>

Rule	Requirements
<b>5 doses before KG 7yr and older</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): PK,</li> <li>• the student is at least 7 years old,</li> <li>• the student receives five doses of the DTaP vaccine,</li> <li>• the student receives their first dose on or after 6 weeks of age,</li> <li>• the student receives the fourth dose on or after 1 year of age,</li> <li>• the student receives the fifth dose on or after 4 years of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 week,</li> <li>• the difference between the fourth and previous dose is greater than or equal to 4 months, and</li> <li>• the difference between the fifth and previous dose is greater than or equal to 6 months.</li> </ul>

A student is considered to be **In Process** when the student is not compliant and any of the following are true:

- when either of the first 2 doses were given within the past 4 weeks.
- when the 3rd dose was given within the past 4 months.
- when the 4th dose was given within the past 6 months.

## Tdap

Rule	Requirements
<b>Grade 7 under 10 yrs</b> <i>No Requirement</i>	<p>Students in state grade: 07 who are no older than 119 months are not required to receive any doses of the Tdap vaccine.</p>
<b>Grade 8-12 under 7 yrs</b> <i>No Requirement</i>	<p>Students in state grade: 08, 09, 10, 11, 12 who are no older than 83 months are not required to receive any doses of the Tdap vaccine.</p>
<b>1 dose Grade 7 10 yr+</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 120 months old,</li> <li>• the student is in state grade: 07,</li> <li>• the student receives one dose of the Tdap vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 120 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose required grades 8-12 7+ yr</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 84 months old,</li> <li>• the student is in state grade: 08, 09, 10, 11, 12</li> <li>• the student receives one dose of the Tdap vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>1 dose grades 7-12</b> <i>Non-Compliant</i>	<p>Students are considered non-compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: 07, 08, 09, 10, 11, 12, and</li> <li>• the student has not received any doses of the Tdap vaccine.</li> </ul>

## Hepatitis B

Rule	Requirement
<b>Ages 0-2 months</b> <i>No Requirement</i>	<p>Students 2 months old and younger are not required to receive any doses of the Hepatitis B vaccine.</p>
<b>1 Dose</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 3 months, but no older than 4 months old, and</li> <li>• the student receives one dose of the Hepatitis B vaccine.</li> </ul>
<b>2 Doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months, but no older than 18 months old,</li> <li>• the student receives two doses of the Hepatitis B vaccine, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>3 Doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives three doses of the Hepatitis B vaccine,</li> <li>• the student receives the last dose on or after 24 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 8 weeks, and</li> <li>• the difference between the third and first dose is greater than or equal to 16 weeks.</li> </ul>

Rule	Requirement
<b>3 Doses grades 7-12</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): 07, 08, 09, 10, 11, 12,</li> <li>• the student receives three doses of the Hepatitis B vaccine,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days,</li> <li>• the difference between the third and previous dose is greater than or equal to 56 days, and</li> <li>• the student receives the last dose on or after 168 days of age.</li> </ul>
<b>2 Adult Doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 11 years old or older,</li> <li>• the student receives two adult doses of the Hepatitis B vaccine,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 months, and</li> <li>• the two doses are received by the student between the ages of 11 and 15 years old.</li> </ul>

A student is considered to be **In Process** when the student is not compliant and any of the following are true:

- when the 1st dose was given within the past 4 weeks.
- when the 2nd dose was given within the past 8 weeks.
- when the student has been given 2 doses with the 1st dose within the past 16 weeks.

## MMR

Rule	Requirements
<b>2 Doses KG and higher</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives two doses of the MMR vaccine,</li> <li>• the student receives the first dose on or after 12 months of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>Ages 0-15 months</b> <i>No Requirement</i>	<p>Students 15 months old and younger are not required to receive any doses of the MMR vaccine.</p>

Rule	Requirements
<b>1 Dose Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the MMR vaccine,</li> <li>• the student receives the dose between 16 months and 6 years of age, and</li> <li>• the student receives the first dose on or after 12 months of age.</li> </ul>
<b>2 Doses Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives two doses of the MMR vaccine,</li> <li>• the student is 7 years old or older and not yet enrolled in KG,</li> <li>• the student receives the first dose on or after 12 months of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>

A student is considered to be **In Process** when the student is not compliant and the 1st dose was given within the past 4 weeks.

## Varicella

Rule	Requirements
<b>Grades 7-12 No Requirement</b>	<p>Students in state grade(s): 07, 08, 09, 10, 11, 12 are not required to receive any doses of the Varicella vaccine.</p>
<b>1 Dose Grade 6 Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: 06,</li> <li>• the student receives one dose of the Varicella vaccine, and</li> <li>• the student receives the first dose on or after 12 months of age.</li> </ul>
<b>2 Doses Grades KG-5 Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG, 01, 02, 03, 04, 05,</li> <li>• the student receives two doses of the Varicella vaccine,</li> <li>• the student receives the first dose on or after 12 months of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>Ages 0-15 months No Requirement</b>	<p>Students 15 months old and younger are not required to receive any doses of the Varicella vaccine.</p>

Rule	Requirements
<b>1 Dose Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the Varicella vaccine</li> <li>• the student receives the dose between 16 months and 6 years of age, and</li> <li>• the student receives the first dose on or after 12 months of age.</li> </ul>
<b>2 Doses Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is 7 years old or older and not yet enrolled in KG,</li> <li>• the student receives two doses of the Varicella vaccine,</li> <li>• the student receives the first dose on or after 12 months of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>

A student is considered to be **In Process** when the student is not compliant and the first dose was given within the past 3 months.

## Polio

Rule	Requirements
<b>4 Doses KG-2 Compliant</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG,</li> <li>• the student receives four doses of the Polio vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the student receives the fourth dose on or after 4 years of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 week, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 6 months.</li> </ul>

Rule	Requirements
<b>3 Doses KG-2</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG,</li> <li>• the student receives three doses of the IPV, OPV, or IPV,OPV Polio vaccine,</li> <li>• the student receives the first dose on or after 42 days of age,</li> <li>• the student receives the third dose on or after 4 years of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days, and</li> <li>• the difference between the third and previous dose is greater than or equal to 6 months.</li> </ul>
<b>4 Doses Grades 3-12</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• the student receives four doses of the Polio vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 6 months.</li> </ul>
<b>3 Doses Grades 3-12</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• the student receives three doses of the Polio vaccine,</li> <li>• the student receives the third dose on or after 4 years of age,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>Over 18</b> <i>No Requirement</i>	<p>Students 18 years old or older are not required to receive any doses of the Polio vaccine.</p>
<b>Ages 0-2 months</b> <i>No Requirement</i>	<p>Students 2 months old or younger are not required to receive any doses of the Polio vaccine.</p>

Rule	Requirements
<b>1 Dose Age 3-4 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 3 months, but no older than 4 months old,</li> <li>• the student receives one dose of the Polio vaccine, and</li> <li>• the student receives the first dose on or after 6 weeks of age.</li> </ul>
<b>2 Doses Ages 5-18 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months, but no older than 18 months old,</li> <li>• the student receives two doses of the Polio vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>3 Doses 19 months-6 years</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 19 months, but no older than 6 years old,</li> <li>• the student receives three doses of the Polio vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>4 Doses Ages 7yr+</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 19 months, but no older than 6 years old,</li> <li>• the student receives four doses of the Polio vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the student receives the fourth dose on or after 4 years of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the fourth and previous dose is greater than or equal to 6 months.</li> </ul>

A student is considered to be **In Process** when the student is not compliant and any of the following are true:

- when the 1st or 2nd dose was given within the past 4 weeks.
- when the 3rd dose was given within the past 8 weeks.
- when the student has had 3 doses and is under 4 years of age.

# Pneumococcal

Rule	Requirements
<b>Grades K-12</b> <i>No Requirement</i>	Students in grade(s): K, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12 are not required to receive any doses of the Pneumococcal PPV or PCV vaccine.
<b>Ages 0-2 months</b> <i>No Requirement</i>	Students 2 months old and younger are not required to receive any doses of the Pneumococcal PPV or PCV vaccine.
<b>1 Dose Ages 3-4 months</b> <i>No Requirements</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 3 months, but no older than 4 months old,</li> <li>• the student receives one dose of the Pneumococcal PPV or PCV vaccine, and</li> <li>• the student receives the first dose on or after 6 weeks of age.</li> </ul>
<b>2 Doses Ages 5-6 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months, but no older than 6 months old,</li> <li>• the student receives two doses of the Pneumococcal PPV or PCV vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>3 Doses Ages 7-15 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 7 months, but no older than 15 months old,</li> <li>• the student receives three doses of the Pneumococcal PPV or PCV vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks.</li> </ul>

Rule	Requirements
<b>4 Doses Ages 16 months - 5 years</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 16 months, but no older than 5 years old,</li> <li>• the student receives four doses of the Pneumococcal PPV or PCV vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the student receives the fourth dose on or after 12 months of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 8 weeks.</li> </ul>
<b>2 Doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives two doses of the Pneumococcal PPV or PCV vaccine,</li> <li>• the student receives the first dose on or after 12 months of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 8 weeks.</li> </ul>
<b>1 Dose</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the Pneumococcal PPV or PCV vaccine, and</li> <li>• the student receives the first dose on or after 24 months of age.</li> </ul>
<b>Ages 6 years and older</b> <i>No Requirement</i>	<p>Student 6 years old and older are not required to receive any doses of the Pneumococcal PPV or PCV vaccine.</p>

A student is considered to be **In Process** when the student is not compliant and any of the following are true:

- when the 1st or 2nd dose was given within the past 4 weeks.
- when the 3rd dose was given within the past 8 weeks.
- when the student has had 3 doses and is under 12 months of age.

## Hib

Rule	Requirements
<b>Grades K-12</b> <i>No Requirement</i>	<p>Students in grade(s): K, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12 are not required to receive any doses of the Hib vaccine.</p>

Rule	Requirements
<b>Ages 0-2 months</b> <i>No Requirement</i>	Students 2 months old and younger are not required to receive any doses of the Hib vaccine.
<b>1 Dose Ages 3-4 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 3 months, but no older than 4 months old,</li> <li>• the student receives one dose of the Hib vaccine, and</li> <li>• the student receives the first dose on or after 6 weeks of age.</li> </ul>
<b>2 Doses Ages 5-6 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months, but no older than 6 months old,</li> <li>• the student receives two doses of the Hib vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>3 Doses Ages 7-15 months</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 7 months, but no older than 15 months old,</li> <li>• the student receives three doses of the Hib vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>4 Doses Ages 16 months - 5 years</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 16 months, but no older than 5 years old,</li> <li>• the student receives four doses of the Hib vaccine,</li> <li>• the student receives the first dose on or after 6 weeks of age,</li> <li>• the student receives the fourth dose on or after 12 months of age,</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks,</li> <li>• the difference between the third and previous dose is greater than or equal to 4 weeks, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 8 weeks.</li> </ul>

Rule	Requirements
<b>2 Doses</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives two doses of the Hib vaccine,</li> <li>• the student receives the first dose on or after 12 months of age, and</li> <li>• the difference between the second and previous dose is greater than or equal to 4 weeks.</li> </ul>
<b>1 Dose</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives one dose of the Hib vaccine, and</li> <li>• the student receives the first dose on or after 15 months of age.</li> </ul>
<b>Ages 6 years and older</b> <i>No Requirement</i>	Students 6 years old and older are not required to receive any doses of the Hib vaccine.

A student is considered to be **In Process** when the student is not compliant and any of the following are true:

- when the 1st or 2nd dose was given within the past 4 weeks.
- when the 3rd dose was given within the past 8 weeks.
- when the student has had 3 doses and is under 12 months of age.
