The following information describes vaccine compliance rules as defined by the South Dakota State Department of Health.

**Read** - View existing vaccines.

## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age shall be counted as valid.
- Doses administered 5 days earlier than the minimum interval or age shall not be counted as valid doses and must be repeated when age-appropriate.

## DTaP

| <b>6 doses before age 4</b><br><i>Compliant</i> | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives 6 doses of the Tdap, DT, Td, or DTaP/DTP vaccine, and</li> <li>• the difference between the sixth dose and the student's birthdate is less than 48 months (4 years) with a 4 day tolerance.</li> </ul> |

| Rule   | Requirements  |

| <b>4 doses</b><br><i>Compliant</i>           | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 4 doses of the DT or DTaP/DTP vaccine, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months (4 years) with a 4 day tolerance.</li> </ul>  |
| <b>3 doses, age 7-10</b><br><i>Compliant</i> | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the students is at least 84 months (7 years) old, but no older than 131 months,</li> <li>the student receives 3 doses of the DTaP, DT, Td or Tdap vaccine, and</li> <li>the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance.</li> </ul>  |
| <b>3 doses, age 11+</b><br><i>Compliant</i>  | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the students is at least 132 months (11 years) old,</li> <li>the student receives 3 doses of the Tdap, DT, Td, or DTaP/DTP vaccine, and               <ul style="list-style-type: none"> <li>the student receives 2 doses of the Td vaccine,</li> <li>the student receives 1 dose of the Tdap vaccine,</li> </ul> </li> <li>the difference between the third dose and the previous is greater than 6 months with a 0 (zero) day tolerance.</li> </ul> |

| <b>1 dose</b><br><i>Compliant</i>             | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 06,</li> <li>the student receives 1 dose of the Tdap, Td, or <del>DTaP/DTP</del> vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 120 months with a 4 day tolerance.</li> </ul>                                    |
| <b>1 dose new student</b><br><i>Compliant</i> | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>student has a State Enrollment of exactly 1 year,</li> <li>the student is in state grade: 06,</li> <li>the student receives 1 dose of the Tdap, Td vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 120 months with a 4 day tolerance.</li> </ul> |

| <b>1 dose &gt; 13 year old</b><br>In Progress | Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 156 months (13 year) old,</li> <li>the student receives 1 dose of the MMRV or Varicella vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>  |
| <b>1 dose &lt; 13 year old</b><br>In Progress | Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at no older than 155 months old,</li> <li>the student receives 1 dose of the MMRV or Varicella vaccine, and</li> <li>the difference between the last dose and the effective date is less than 2 months with a 0 (zero) day tolerance.</li> </ul>   |

| <b>3 doses</b><br><i>Compliant</i>     | Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives 3 doses of the IPV, OPV or the IPV/OPV Polio vaccine,</li> <li>• the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance, and</li> <li>• the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance.</li> </ul> |
