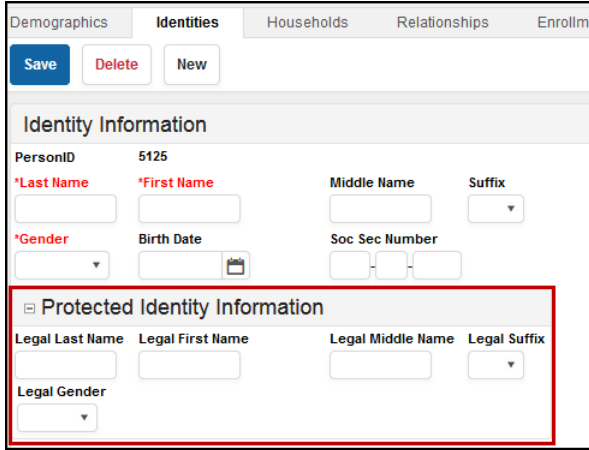

Behavior Referrals in Draft status are excluded.

Field	Description
<b>Submission Code for File Name</b>	The report naming convention based on the submission time frame of the report.
<b>Extract Type</b>	17 CIRS Offenders
<b>Effective Date</b>	The date from which data is pulled for the report.

Field	Description
<b>Format</b>	Determines the format for the report. Use <b>State Submission</b> when submitting the final data. Use <b>HTML</b> for data review and testing.
<b>Report Legal Identities</b>	<p>When this checkbox is marked, Campus reports the legal name entered on the Census &gt; People &gt; Identities tab. If only one part of the Protected Identity Information is entered, that part reports and the other name fields report blank.
