The following information describes vaccine compliance rules as defined by the Rhode Island Department of Health.

General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days earlier than the minimum interval or age are not considered valid doses and must be repeated as age-appropriate.

DTap DTP

Rule	Requirements
0-2 months <i>No requirement</i>	Students age 0-2 months old are not required to receive any doses of the DT, Tdap, Td, or DTaP-DTP vaccine.

Rule	Requirements
3-4 months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 3 months, but no older than 4 months old, and the student receives one dose of the DT, Tdap, Td, or DTaP-DTP vaccine.
5-6 months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 5 months, but no older than 6 months old, and the student receives two doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
7-18 months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 7 months, but no older than 18 months old, and the student receives three doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
19 months and older <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 19 months old, and the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
5 doses <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and the student receives five doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
4th dose after 4yrs <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine, the difference between the first dose and the student's birthdate is less than 42 days with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the fourth dose and the previous is greater than 4 months with a 4 day tolerance, and the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.

Rule	Requirements
4th dose 7 yrs or older <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 84 months old, the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine, the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.
3 doses 7 yrs or older <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 84 months old, the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, the student receives three doses of the DT, Tdap, Td, or DTaP-DTP vaccine, the difference between the first dose and the student's birthdate is less than 12 months with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance, and the difference between the third dose student's birthdate is greater than 48 months with a 4 day tolerance.
Default K-12 <i>Non-compliant</i>	Students in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12 who have not received any doses of the DT, Tdap, Td, or DTaP-DTP vaccine are considered non-compliant.

Tdap

Rule	Requirements
1 dose <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> student is in state grade 07, 08, 09, 10, 11, 12, and the student receives 1 dose of the Tdap vaccine.

Rule	Requirements
No Doses <i>Non-compliant</i>	Students in state grade 07, 08, 09, 10, 11, 12, who have not received any doses of the Tdap vaccine are non-compliant.

Hepatitis B

Rule	Requirements
0-2 Months <i>No Requirement</i>	Students age 0-2 months old are not required to receive any doses of the Hepatitis B vaccine.
3-4 Months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 3 months, but no older than 4 months old, and the student receives one dose of the Hepatitis B vaccine.
5-18 Months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 5 months, but no older than 18 months old, and the student receives two doses of the Hepatitis B vaccine.
19 months and older <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 19 months old, and the student receives three doses of the Hepatitis B vaccine.

Polio

Rule	Requirements
0-2 months <i>No Requirement</i>	Students age 0-2 months old are not required to receive any doses of the IPV, OPV, or IPV-OPV Polio vaccine.
3-4 months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 3 months, but no older than 4 months old, and the student receives one dose of the IPV, OPV, or IPV-OPV Polio vaccine.
5-18 months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 5 months, but no older than 18 months old, and the student receives two doses of the IPV, OPV, or IPV-OPV Polio vaccine.

Rule	Requirements
19 months <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is at least 19 months old, and the student receives three doses of the IPV, OPV, or IPV-OPV Polio vaccine.
18 yrs and older <i>No Requirement</i>	Students age 216 months (18 years) old and older are not required to receive any doses of the IPV, OPV, or IPV-OPV Polio vaccine.
4 doses <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, the student receives four doses of the IPV, OPV, or IPV-OPV Polio vaccine, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the fourth dose and the previous is greater than 28 days with a 4 day tolerance, and the difference between the fourth dose and the birthdate is greater than 48 months with a 4 day tolerance.
3 doses IPV <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, the student receives three doses of the IPV, or IPV-OPV Polio vaccine, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.
3 doses OPV <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, the student receives three doses of the OPV, or IPV-OPV Polio vaccine, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.
