The eTranscript functionality allows schools to generate an electronic version of student transcripts, which can be submitted to post-secondary establishments and third-party vendors for use in applying for acceptance into a college or university. When a grade level is marked as Exclude from GPA on the [Grade Levels](#) editor, courses taken by a student during those grade levels may still display on the transcript (depending on other course setup scenarios). This only indicates that scores received from courses taken during that grade level are NOT factored into GPA calculations.

1.	Assign tool rights to eTranscripts for the appropriate users (see table below).	User Groups > Tool Rights
2.	Verify the school's <a href="#">CEEB number</a> is entered.	School Information > School > School Detail > CEEB Number

## eTranscript Errors and Trouble Shooting

The following information can be used to troubleshoot errors you may receive when generating eTranscripts. The

solutions listed may help with correcting errors. If you have attempted the solution and are still receiving errors, please contact Campus Support for assistance.

Note the following:

- The XML Layout includes a message in a gray bar at the beginning of the report. As XML is not designed to be user-friendly, style information is not included. **This is not an error.**

- The popup message on the interface may not always show the full error due to a database character limit. This may happen when errors occur for five or more students.
