## Report Logic

Only one record per school year reports.

When a student has multiple CTE records, the CIP with the most recent Start Date reports.

When more than one record is within the reporting dates, the most recent Start Date closest but beyond the Effective Date of the entered report generation date reports. When the Start Dates are the same, the record reports with a blank end date. When both end dates are blank and start dates are the same, the most recent created CTE record, using record ID, reports.

Student enrollments marked as [State Exclude](#) do not report.

## Generate the CTE Student Fact Template

1. Select **CTE Student Fact Template** from the **Extract Type** dropdown list.
2. Enter the **Effective Date** of the extract in *mmdyy* format or use the calendar icon to select a date.
3. Enter the **Prior Reporting Date** of the extract in *mmdyy* format or use the calendar icon to select a date.
4. Select the **Format** of the extract.
5. Optional: select an existing **Ad hoc Filter** from which to report students. Only those students included in the filter and who meet the reporting population are included in the extract.
6. Select the desired **Grades** to include in the report.
7. Select the appropriate **Calendar(s)** from which to include data on the extract.
8. Click the **Generate Extract** button or the **Submit to Batch** button, when available. The extract displays in the selected format.
