



<b>Education Plan</b>	Prints on the first page of the IEP	The Education Plan editor includes general meeting and screening information and lists the dates associated with the plan, such as dates the plan is active.	This editor must be saved before continuing to other areas of the plan.
<b>Student Demographics</b>	Prints on the first page of the IEP	The Student Demographics editor populates basic information about the student such as demographic data, address and school information.	Clicking <b>Refresh Student Information</b> will synchronize information in the editor with the most recent information entered for the student from the <a href="#">Demographics</a> , <a href="#">Households</a> , <a href="#">Enrollments</a> and <a href="#">School</a> tabs.
<b>Parent/Guardian Demographics</b>	Prints on the first page of the IEP	The Parent/Guardian Demographics editor populates based on the established student/guardian relationships created on the student's <a href="#">Relationships</a> tab or indicated by the guardian checkbox on the Households tab. The editor includes Demographics information for the student's guardian.	Clicking <b>Refresh Guardian Information</b> will synchronize information in the editor with the most recent information from the student's guardian's Demographics and Households tabs.

<b>Enrollment Status</b>	Prints on the first page of the IEP	The Enrollment Editor provides a snapshot of the student's enrollment data.	<p>Clicking <b>Get Special Ed Status from Enrollment</b> will synchronize the information in the editor with the most recent information from the student's Enrollments tab.</p> <p>When establishing the Plan Type in System Administration, three Enrollment editors are available. Users should choose the editor that best meets their needs. The second editor is the most commonly used.</p>
<b>Extended School Year 3 - 5</b>	Initiation and Duration of Extended Year	The Extended School Year 3 - 5 editor indicates if extended school year services are needed for the student to complete his or her education.	N/A

<b>Tran from Part C to Part B Data 3 - 5</b>	Transition from Part C to Part B Data Collection	The Transition from Part C to Part B Data Collection List 3 - 5 editor lists the Transition Service(s) the student will receive to transition from Part C to Part B services.	Only complete this section for children who have received Part C CIS/EI services and are eligible for Part B EEE services at age 3.
<b>Present Levels of Performance 3 - 5</b>	Present Levels of Educational and Functional Performance 3-5	The Present Levels of Educational and Functional Performance 3 - 5 provides a concise overview of the student's current skills and serves as the basis of the student's program for the upcoming year.	N/A
<b>Global Outcome Area Editor 3 - 5</b>	Global Outcome Area	The Global Outcome Area 3 - 5 editor lists the domain areas (social/emotional, adaptive, communication, fine/gross motor, and/or cognitive skills) addressed within the outcome area.	N/A

<b>Early Learning Goals and Objective</b>	Vermont Early Learning Standards	The Early Learning Goals and Objective editor lists the students goals towards meeting an early learning standard.	<a href="#">Template Banks</a> are established in System Administration and available by clicking the white paper icon.
<b>SPED Services 3 - 5</b>	Special Education Services, Related Services, Consent to Bill Medicaid	The Special Education Services 3 - 5 editor lists services provided to the student in a Special Education setting.	Only active <a href="#">Services</a> with a Type of <i>Normal Service</i> can be included in this editor. <a href="#">Services</a> , <a href="#">Service Providers</a> and <a href="#">Service Positions</a> are established in System Administration.
<b>Related Services 3 - 5</b>	Special Education Services, Related Services, Consent to Bill Medicaid	The Related Services 3 - 5 editor lists developmental, corrective or other supportive services required to assist the student with a disability.	Only active Services with a Type of <i>Related</i> can be included in this editor. Services, Service Providers and Service Positions are established in System Administration.

<b>Parental Consent to Bill Medicaid</b>	Special Education Services, Related Services, Consent to Bill Medicaid	The Parental Consent to Bill Medicaid editor identifies if the parent gives consent to bill medicaid for the services listed in the student's plan and to release any necessary special education records to a physician/nurse practitioner in order for them to reach a determination that the services are medically necessary. <b>EC Ed. Environment/Placement 3 - 5</b>	Educational Environment/Placement, Accommodations/Modifications for Assessments	The Early Childhood Educational Environment/Placement 3 - 5 editor describes the student's early childhood environment/placement and an explanation of the extent, if any, to which the preschooler will not participate with same age peers in a regular early childhood setting.	Some fields located in this editor come from the Enrollment tab and cannot be modified in the editor.
<b>Accom./Mod., Assist. Tech. and/Sup. Aids 3 - 5</b>	Accommodations, Modifications, Assistive Technology and/or Supplementary Aids	The Accommodations, Modifications, Assistive Technology and/or Supplementary Aids 3 - 5 editor identifies the environmental accommodations, curriculum modifications, supplementary aids, assistive technology etc. that will support the child's access to and participation in a regular early childhood setting and/or in age appropriate activities. <b>Assessment Data Collection and Reporting 3 - 5</b>	Early Childhood Outcomes and PreK (Act 62) Assessment Data Collection and Reporting	The Assessment Data Collection and Reporting 3 - 5 editor identifies the IEP team's decision on how the student's annual progress will be assessed.	N/A
