## Report Editor

Field	Description
<b>Pre ID</b>	Selection indicates which assessment for which the labels will generate.
<b>Effective Date</b>	The entered date reflects the students' active enrollment date. A student not enrolled (enrollment ended) on the entered date will not be included in the labels unless the Include Active Students checkbox is marked. Dates are entered in mmddyy format, or you can use the calendar icon to select a date.
<b>Use Enrollment Programs</b>	Program participation records are reported when the checkbox is NOT selected (the default). When the checkbox is marked, program fields on the enrollment record are considered.
<b>Grade Level</b>	Indicates the grade level of enrollment for which the labels will generate.

<b>Ad Hoc Filter</b>	If a filter is selected (and not a grade level), labels will only generate for students included in the filter.
<b>Format</b>	Determines how the labels will be generated. <ul style="list-style-type: none"> <li>State Format (Fixed Width)</li> <li><u>CSV</u></li> <li>HTML</li> </ul>
<b>Include Inactive Students</b>	When selected, inactive students will be included in the extract, regardless of the entered Effective Date.

<b>Calendar Selection</b>	Selection indicates the school calendar that will be used when generating the report.

## Generate the Pre-ID Biology Extract

1. Select the **EOC Biology** option from the **PreID** dropdown list.
2. Enter an **Effective Date** for the report.
3. Select the students in the report by selecting **Grade levels** or an **Ad hoc Filter**.
4. Select the **Format** of the extract - **State Format (Fixed Width)**, **CSV** or **HTML**. Use the HTML or CSV format for testing and data review purposes. Use the State Format when submitting the data to the state.
5. Mark the **Include Inactive Students** checkbox to include students who do not have an active enrollment record as of the entered effective date.
6. Select the **calendar to include in** the report. This option defaults to the calendar selected in the Campus toolbar.
