#### **Report Editor**

Field	Description
Pre ID	Selection indicates which assessment for which the labels will generate.
Effective Date	The entered date reflects the students' active enrollment date. A student not enrolled (enrollment ended) on the entered date will not be included in the labels unless the Include Active Students checkbox is marked. Dates are entered in mmddyy format, or you can use the calendar icon to select a date.
Use Enrollment Programs	Program participation records are reported when the checkbox is NOT selected (the default). When the checkbox is marked, program fields on the enrollment record are considered.
Grade Level	Indicates the grade level of enrollment for which the labels will generate.



Field	Description
Ad Hoc Filter	If a filter is selected (and not a grade level), labels will only generate for students included in the filter.
Format	Determines how the labels will be generated. <ul> <li>State Format (Fixed Width)</li> <li>CSV</li> <li>HTML</li> </ul>
Include Inactive Students	When selected, inactive students will be included in the extract, regardless of the entered Effective Date.
Exclude Cross-Site Data	<ul> <li>Cross-site section enrollment data is <u>not</u> included in the report when checked.</li> <li>Cross-site enrollment functionality must be enabled at the district level for the checkbox to display.</li> <li>Defaults to checked.</li> </ul>
Calendar Selection	Selection indicates the school calendar that will be used when generating the report.

### **Generate the Pre-ID NJASK Extract**

- 1. Select the NJASK option from the **PreID** dropdown list.
- 2. Enter an **Effective Date** for the report.
- 3. Select the students to include in the report by selecting **Grade levels** or an **Ad hoc Filter** that includes the students to be reported on the NJ ASK report.
- Select the Format of the extract State Format (Fixed Width), CSV or HTML. Use the HTML or CSV format for testing and data review purposes. Use the State Format when submitting the data to the state.
- 5. Mark the **Include Inactive Students** checkbox to include students who do not have an active enrollment record as of the entered effective date.
- 6. Select the **Calendar** to include in the report. This option defaults to the calendar selected in the Campus toolbar.
