<p><b>Enrollment Status</b></p>	<p>The Enrollment Editor provides a snapshot of the student's enrollment data.</p>	<p>Clicking <b>Get Special Ed Status from Enrollment</b> synchronizes the information in the editor with the most recent information from the student's <a href="#">Enrollments</a> tool.</p> <p>When a Disability of SLD or DD is chosen as the Primary Disability or Disability 2, a list of subcategories displays below for further clarification.</p> <p>When establishing the <a href="#">Plan Type</a> in System Administration, three Enrollment editors are available. Users should choose the editor that best meets their needs. The second editor is the most commonly used.</p>
<p><b>Placement and LRE</b></p>	<p>The Placement and Least Restrictive Environment editor records information related to the student's placement and interaction with non-disabled peers.</p>	<p>N/A</p>

<p><b>Student Demographics</b></p>	<p>The Student Demographics editor populates basic information about the student such as demographic data, address and school information.</p>	<p>Clicking <b>Refresh Student Information</b> synchronizes information in the editor with the most recent information entered for the student from the <a href="#">Demographics</a>, <a href="#">Households</a>, <a href="#">Enrollments</a> and <a href="#">School</a> tools.</p>
<p><b>Parent/Guardian Demographics</b></p>	<p>The Parent/Guardian Demographics editor populates based on the established student/guardian relationships created on the student's <a href="#">Relationships</a> tool or indicated by the guardian checkbox on the <a href="#">Households</a> tool. The editor includes <a href="#">Demographics</a> information for the student's guardian.</p>	<p>Clicking <b>Refresh Guardian Information</b> synchronizes information in the editor with the most recent information from the student's guardian's <a href="#">Demographics</a> and <a href="#">Households</a> tools.</p>
<p><b>Team Meeting</b></p>	<p>The Team Meeting editor lists the team meetings held regarding the student.</p>	<p>Before team meetings can be added, the student must have team members added on the <a href="#">Team Members</a> tool.</p> <p>The <b>Print in IEP</b> checkbox must be marked for the team meeting to appear on the printed document.</p> <p>Five specific Roles are required to Save the editor, Parent/Guardian, General Education Teacher, Special Education Teacher, PEA Representative, and Test Result Interpreter.</p>

<b>Present Level of Academic Achievement and Function (PLAAFP)</b>	The Present Level of Academic Achievement and Function (PLAAFP) editor provides a summary of the student's current achievement in school. This editor includes areas for parent and student input and a description of various kinds of assistance the student could be receiving.	N/A
<b>Consideration of Special Factors</b>	The Consideration of Special Factors editor identifies possible concerns that may interfere with the student's learning, such as behavior issues, limited English proficiency, visual or communication impairments or assistive technology.	N/A
<b>Measurable Annual Goal and Objectives</b>	The Measurable Annual Goals and Objectives editor lists the annual goals the student is working toward within the time frame of the IEP and the objectives or benchmarks identified to achieve those goals.	The ESY checkbox should be marked when the student is ESY Eligible to display in the ESY editor.
<b>Progress toward Annual Goals</b>	The Progress toward Annual Goals editor is used to document the manner in which the student's progress toward the annual goals and the extent to which the progress is sufficient to enable the student to achieve the goals.	The ESY checkbox should be marked when the student is ESY Eligible to display in the ESY editor.
<b>Accommodations for Instruction/Assessments</b>	The Accommodations for Instruction/Assessments editor is used to document any changes in how the student accesses information and demonstrates learning. Accommodations do not substantially change the instructional level, content or performance criteria.	N/A

<b>Modifications for Instruction/Assessments</b>	The Modification for Instruction/Assessments editor is used to document any modifications to the student's curriculum and expectations of the student's mastery of essential skills.	N/A
<b>Assessment Participation</b>	The Assessment Participation editor is used to document the manner in which the student participates in assessments.	N/A
<b>Special Education Services</b>	The Special Education Services editor lists services provided to the student in a Special Education setting.	Only active <a href="#">Services</a> with a Type of <i>Normal Service</i> can be included in this editor. <a href="#">Services</a> and <a href="#">Service Positions</a> are established in System Administration.
<b>Related Services</b>	The Related Services editor lists developmental, corrective or other supportive services required to assist the student with a disability.	Only active <a href="#">Services</a> with a Type of <i>Related</i> can be included in this editor. <a href="#">Services</a> and <a href="#">Service Positions</a> are established in System Administration.
<b>Supplementary Aids and Services</b>	The Supplementary Aids and Services editor lists additional supports provided to the student, such as consultations. <b>Supports for School Personnel Services</b>	The Supports for School Personal Services editor lists services for school staff to assist them in providing special education services. <b>Extended School Year</b>	The Extended School Year editor indicates extended school year services are needed for the student to complete his or her education.	<a href="#">Template Banks</a> are established in System Administration and available by clicking the white paper icon next to the Comments area.
<b>Transition Services</b>	The Transition Services editor identifies specific post secondary transition services provided to the student in various areas and strategies designed to improve the student's post secondary success.	<a href="#">Template Banks</a> are established in System Administration and available by clicking the white paper icon next to the Strategy area.
<b>Post Secondary Goals</b>	The Post Secondary Goals editor is used to document the student's goals for post secondary life and/or education.	N/A
<b>Transition Services Activities</b>	The Transition Services editor includes sections for describing possible transition options based on student preference and transition assessment results, goals related to the student's post-secondary achievement and a summary of the student's projected graduation information.	<a href="#">Template Banks</a> are established in System Administration and available by clicking the white paper icon next to the Training/Education, Employment and Independent Living Skills areas.
<b>Courses of Study</b>	The Courses of Study editor lists the courses the student needs to complete to meet the established post secondary goals.	<a href="#">Template Banks</a> are established in System Administration and available by clicking the white paper icon next to the Course of Study area.
<b>IEP Signature Page</b>	The IEP Signature Page includes the language found on the printed document for verifying that appropriate communication with the needed individuals was completed, including a list of documents that may need to be provided to the signer.	This signature page is used for public school students. The checkboxes in this section indicate which documents the parent/guardian received at the meeting for this IEP.

<b>Transfer of Rights</b>	The Transfer of Rights editor indicates when the student was notified of the transfer of rights that occurs when the student turns 18.	N/A
<b>Prior Written Notice</b>	The Prior Written Notice editor provides a space for descriptions and explanations related to proposed or refused actions for a student.	N/A
<b>Meeting Notes</b>	The Meeting Notes editor is used to document any notes related to the meeting.	N/A
