Tool Search: PreID Extract

The Pre-ID 2014 Extract is used to submit student Pre-ID information for Science and Social Studies Tests and the Alternate Assessment for Student with Significant Cognitive Disabilities (AASCD). The extract indicates which tests students are eligible for and whether they will take tests online or need labels to apply to paper booklets.

## Report Logic

Reports based on the most recent enrollment within the extract Date Range. To report:

- Enrollments must have a Service Type of P or N. Enrollments cannot be marked as State Exclude or No Show, or be in a calendar or grade level marked as Exclude.
- Students must be enrolled in at least one Course Section during the extract Date Range (unless Test Eligibility: AASCD reports as Y or Test eligibility & mode: OELPA reports as O or P for the student, in which case a course enrollment is not required).

If the district has [configured](#) a vertical reporting connection with [SameGoal](#) and *Pull data from SPED product integration* is marked on the extract editor, special education fields report from SameGoal rather than from documents created in Campus.

## Generating the Extract

1. Enter the **Date Range** in *mmddyy* format or by clicking the calendar icon and selecting a date.
2. Select which calendar(s) to include within the extract.
3. Select the **Format**, either *CSV* or *HTML*.
4. Select an **Ad hoc Filter** if desired to limit students to a pre-defined filter.
5. Indicate if the extract should **Include Protected Identity Info**.
6. Mark **Exclude Dropped Students** to prevent dropped students from being included in the extract.
7. Click **Generate Extract** to generate the report in the indicated format or **Submit to Batch** to schedule when the report will generate.

Users have the option of submitting a report request to the batch queue by clicking **Submit to Batch** instead of Generate Extract. This process will allow larger reports to generate in the background, without disrupting the use of Campus.
