

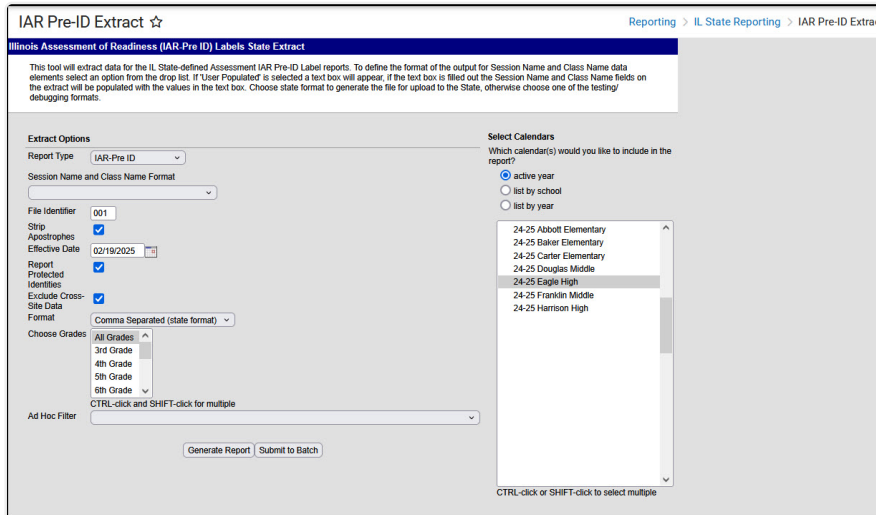

The IAR Pre-ID Extract produces a file for IAR Pre-ID Label reports. Students in grades 03-12 with an active enrollment as of the effective date are included and have a [Test Accommodations](#) record for one of the IAR Assessments.



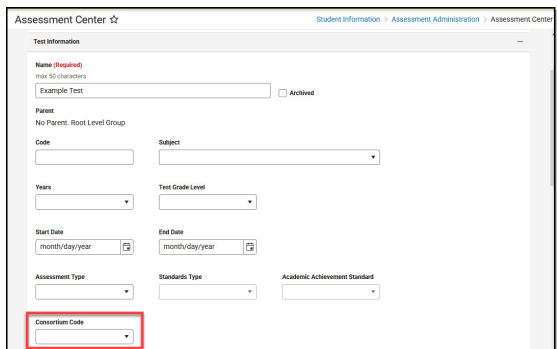
IAR PreID Extract

Report Logic

All students who have an active enrollment as of the entered effective date and are enrolled in grades 03-12 report. If the student has multiple enrollments, the most recent primary enrollment reports; if there is no primary enrollment, the most recent active Special Education or Partial enrollment reports.

Students are included multiple times if they are tied to multiple courses and/or have multiple test accommodation records in the selected calendar that meet the following course criteria:

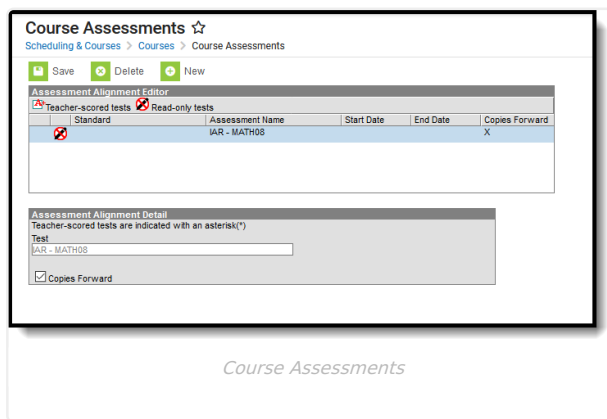
- Active courses are tied to an assessment as of the effective date.
- **Consortium Code** associated with the assessment.

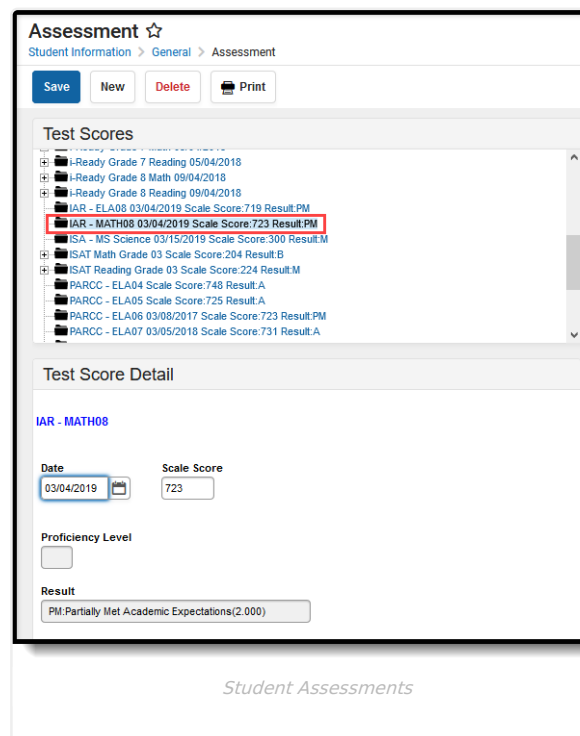
- If the Session Name and Class Name Format is Course Number-Teacher Last Name-Period or Course/Section Number-Teacher Last Name, AND the student is active in multiple sections as of the effective date, both sections report; otherwise, only one record per course reports.

In addition to populating the **Consortium Code**, the assessment needs to be assigned to a **Course** in which the

student is scheduled, and the student must have a score for that assessment.

- Enrollment record
- Grade Level marked
- Calendar

The report sorts data in the following order:

- Test Code
- Assessment Session Name
- Last Name
- First Name

| Report Protected Identities | Student identity information (last name, first name, etc.) reports from the Protected Identity Information fields when marked. |
| Format | The report can be generated in either HTML or in the State Format (Comma Delimited) . The HTML format can be used to review data prior to submission of the extract. The State Format should be used when submitting information to the state. |
| Choose Grades | Users can select a grade level, multiple grade levels or all grade levels. Use the CTRL and SHIFT keys to select multiple grade levels. |
| Ad hoc Filter | Selecting an ad hoc filter further narrows the student set to be only those students who are included in the selected filter. |
| Calendar Selection | A calendar must also be selected when generating the report. This selection only returns students who are enrolled in that calendar and who also meet the reporting criteria. |
| Report Generation | Use the Generate Extract button to immediately display the extract's results. For a larger data set, use the Submit to Batch button. This allows selecting a specific time in which the extract is generated (after school hours). See the Batch Queue article for more information. |

Generate the IAR Pre-ID Report

1. Select the **IAR Pre-ID** as the **Report Type**.
2. If desired, select the **Session Name and Class Name Format** option.
3. Enter the correct **File Identifier**.
4. If desired, mark the **Strip Apostrophes** checkbox.
5. Enter the desired **Effective Date** and the **First Year in US School Date**.
6. If desired, mark the **Report Protected Identities** checkbox.
7. Select the desired **Format**.
8. Choose which **Grades** to include in the report.
9. If desired, select an **Ad hoc Filter**.
10. Choose the desired **Calendars**.
11. Click the **Generate Report** option to display the report's results immediately; choose the **Submit to Batch** button to determine when the report is generated.
