- Active courses & sections
- Active staff & teachers

Child Find (CF)

To report, the following conditions must be met:

Student:

- Student must have an enrollment and be 21 years of age or younger on September 1st in the current school year.
- Student must have an active and locked IEP at some point during the reporting period with a SPED Eligibility Determination Date on or between July 1st and June 30th of the given school year.

Do not report

- Students marked as State Exclude
- Students who have no Unique State ID

CalendarDateExtension

This extension represents a day in the school calendar.

One complex is reported for every day marked as Instructional (System Administration > Calendar > Calendar > Days > Day Detail > Instruction) during the school year AND every day marked as a Waiver Day (System Administration > Calendar > Calendar > Days > Event Type (01, 02, 03, 04, or 99)).

ReportingPeriodExtension

This extension represents a time period for which student attendance data is reported. One complex is reported for each of the six reporting periods for each instructional track. For example, if a school has 4 instructional tracks and 6 attendance periods, then 24 complexes report.

This complex type will only reference CalendarDateReference > ref fields that tie to the school AND calendar being reported.
