Report Logic

The following date logic applies to all record types unless otherwise noted.

- To report, a program must have been active at some point during the reporting year.
- Program records are not included in the extract when the program's End Date is prior to their first Enrollment Start Date. Graduation Seal records are exempt from this logic.

Enrollment Logic

- First, the logic considers all Enrollments active on at least one date on or between the Calendar Start Date and the Effective Date on the extract editor per student.
- Then, only those Enrollments that are also active during the student's reportable program Start and End Dates are considered.
- When the student's program of record reports a Program Code reflecting a Disability Category, a record reports for the student.
 - This includes Program Codes of 5786, 0352, 0363, 0385, 0396, 0407, 0418, 0429, 0440, 0451, 0462, 0473, 0484 or 0495.
- When the student's program of record does NOT report a Program Code reflecting a Disability Category, and the following applies:
 - When only one Enrollment is active, and the Start Status is 5905, a record does not report for the student.
 - When more than one Enrollment is active, and all active Enrollments have a Start Status of 5905, a record does not report for the student.
 - When more than one Enrollment is active, and at least one Enrollment has a Start Status of 5905, a record reports for the student.

Records report when they meet the following logic. Some records report when they meet a specific set of conditions while others report when specific fields are filled, for example, on the EL Services tool or the Homeless Services tool. The numbers mentioned in the Logic column below report in the Program Codes element on the report.
