Report Editor Details

The following table defines the fields on the English Language Learning and Immigrant Students Report Editor.

Editor Field	Description
Snapshot Date	The date for which ELL and Immigrant Student data is collected. A date can be entered, but selecting a calendar will overwrite that date with a predetermined snapshot date.
Format	The format in which the report will generate. Options include HTML, Comma Separated and XML.
Ad Hoc Filter	The Ad Hoc Filter allows you to narrow search results to specific students.
Calendars	The calendar(s) from which data is pulled for the report. Can be set to display only the active year's calendars, or be sorted by school or by year. Selecting a calendar will enter a default Snapshot Date in that field.
Submit to Batch	Users have the option of submitting a report request to the batch queue by clicking Submit to Batch instead of Generate Extract. This process allows larger reports to generate in the background, without disrupting the use of Campus. For more information about submitting a report to the batch queue, see the Batch Queue article.
