The following information describes vaccine compliance rules as defined by the Massachusetts State Department of Health.

**Read** - View existing vaccines.

## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days before the minimum interval or age are not considered valid and must be repeated as age-appropriate.

## Meningococcal

<b>1 dose 20-21</b> <i>Compliant</i> <i>Active End Date:</i> <i>06/30/2021</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is in state grade: 07, and</li> <li>• the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>

<p><b>1 dose 21-22</b> Compliant Active Start date: 07/1/2021 Active End date: 06/30/2022</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, and</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<p><b>1 dose 22-23</b> Compliant Active Start Date: 07/1/2022 Active End Date: 06/30/2023</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, and</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<p><b>1 dose 23-24</b> Compliant Active State Date: 07/1/2024</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, and</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<p><b>2 dose 20-21</b> Compliant Active End Date: 06/30/2021</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 11,</li> <li>the student receives two dose of the Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.</li> </ul>
<p><b>2 dose 21-22 &amp; beyond</b> Compliant Active Start Date: 7/1/2021</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 11, 12,</li> <li>the student receives two dose of the Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.</li> </ul>
<p><b>1 dose at 16</b> Compliant</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>the difference between the last dose and the birthdate is greater than 192 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>No dose 20-21</b> <i>Non-Compliant</i> <i>Active End Date:</i> <i>6/30/2021</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 11, and</li> <li>the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>No dose 21-22</b> <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2021</i> <i>Active End Date:</i> <i>6/30/2022</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 11, 12, and</li> <li>the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>No dose 22-23</b> <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2022</i> <i>Active End Date:</i> <i>6/30/2023</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 11, 12, and</li> <li>the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>No dose 23-24 &amp; beyond</b> <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2023</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12, and</li> <li>the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>

## DTaP

Grade	Requirements
<b>PK</b>	4 doses required
<b>K</b>	5 doses required - combined doses of Diphtheria-tetanus-pertussis (DTaP, DTP)
<b>K-12</b>	4 doses required - The difference between the last dose and birth date must be greater than or equal to 4 years.
<b>1-12</b>	3 doses of Td or Tdap

## Tdap

Rule	Requirements
------	--------------

Rule	Requirements
<b>1 dose</b> <b>Grades 7-12</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade(s): 07, 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the Td or Tdap vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>Grades 7-12</b> <b>Default</b> <i>Non-compliant</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade(s): 07, 08, 09, 10, 11, 12, and</li> <li>the student has not received any doses of the Td or Tdap vaccine.</li> </ul>

## Hepatitis B

Students must have received **3 doses** of Hepatitis B to be considered compliant. The default setting is non-compliant.

## MMR

Grade	Dose	End Date
<b>PK</b>	1 dose of MMR or M, M and R	
<b>K-12</b>	2MMR or 1MMR, 1M, 1M and 1R or 2M, 2M and 2R	

## Varicella

Grade	Dose
<b>PK</b>	1 dose
<b>Any</b>	2 doses

## Polio

Doses	Requirements
<b>3 doses required</b>	Grade = PK
<b>4 doses required</b>	Grade = Any
<b>3 doses required</b>	All OPV with the last dose received on or after the 4th birthday.
<b>3 doses required</b>	All IPV with the last dose received on or after the 4th birthday.

# Hib

Grade	Requirement
<b>PK</b>	1 dose
<b>PK</b>	Default setting is Non-Compliant
<b>Any other</b>	Default setting is No Requirement
