General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days before the minimum interval or age are not considered valid and must be repeated as age-appropriate.

<p>1 dose 21-22 Compliant Active Start date: 07/1/2021 Active End date: 06/30/2022</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, and the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.
<p>1 dose 22-23 Compliant Active Start Date: 07/1/2022 Active End Date: 06/30/2023</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, and the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.
<p>1 dose 23-24 Compliant Active State Date: 07/1/2024</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 10, and the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.
<p>2 dose 20-21 Compliant Active End Date: 06/30/2021</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 11, the student receives two dose of the Meningococcal (MCV4 or MenACWY) vaccine, and the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.
<p>2 dose 21-22 & beyond Compliant Active Start Date: 7/1/2021</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 11, 12, the student receives two dose of the Meningococcal (MCV4 or MenACWY) vaccine, and the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.
<p>1 dose at 16 Compliant</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine, and the difference between the last dose and the birthdate is greater than 192 months with a 4 day tolerance.

No dose 20-21 <i>Non-Compliant</i> <i>Active End Date:</i> <i>6/30/2021</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 11, and the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.
No dose 21-22 <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2021</i> <i>Active End Date:</i> <i>6/30/2022</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 08, 11, 12, and the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.
No dose 22-23 <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2022</i> <i>Active End Date:</i> <i>6/30/2023</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 11, 12, and the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.
No dose 23-24 & beyond <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2023</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 10, 11, 12, and the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.

DTaP

Rule	Requirements
5 dose K <i>Compliant</i>	Students are considered compliant when they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned with five doses of the DTaP/DTP combined vaccine.
4 dose PK <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition, they receive four doses of the DT, Td, DTaP/DTP, or Tdap vaccine.

Rule	Requirements
4 doses K-12 <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, they receive four doses of the DT, Td, DTaP/DTP, or Tdap vaccine, and the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.
3 doses Td <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, they receive three doses of the Td or Tdap vaccine.
Default <i>Non-compliant</i>	N/A

Tdap

Rule	Requirements
1 dose Grades 7-12 <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade(s): 07, 08, 09, 10, 11, 12, the student receives one dose of the Td or Tdap vaccine, and the difference between the dose and the student's birthdate is greater than 84 months with a 4 day tolerance.
Grades 7-12 Default <i>Non-compliant</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade(s): 07, 08, 09, 10, 11, 12, and the student has not received any doses of the Td or Tdap vaccine.

Hepatitis B

Students must have received **3 doses** of Hepatitis B to be considered compliant. The default setting is non-compliant.

1 dose PK <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition, they receive one dose of the Measles, MMR, or MMRV vaccine, or they receive one dose of the Mumps, MMR, or MMRV vaccine, or they receive one dose of the Rubella, MMR, or MMRV vaccine.
2MMR K-12 <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and they receive two doses of the MMR or MMRV vaccine.
1 MMR, 1M, 1M, 1R K-12 <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, they receive one dose of the MMR or MMRV vaccine, and they receive one dose of the Measles vaccine, or they receive one dose of the Mumps vaccine, or they receive one dose of the Rubella vaccine.
2M, 2M, 2R K-12 <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, they receive two doses of the Measles vaccine, or they receive two doses of the Mumps vaccine, or they receive two doses of the Rubella vaccine.

1 dose Varicella Grade PK <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition, they receive one dose of the Varicella or MMRV vaccine.
2 dos Varicella <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, they receive two dose of the Varicella or MMRV vaccine.
Default <i>Non-compliant</i>	N/A

Polio

Rule	Requirements
3 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition, they receive three doses of the IPV, OPV, or IPV/OPV Polio vaccine.
4 doses <i>Compliant</i>	Students are compliant when they receive four doses of the IPV, OPV, or IPV/OPV Polio vaccine.
3 doses OPV <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they receive three doses of the OPV or OPV/IPV Polio vaccine, and the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.
3 doses IPV <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they receive three doses of the IPV or IPV/IPV Polio vaccine, and the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.
Default <i>Non-compliant</i>	N/A

Hib

Rule	Requirements
1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition, they receive one dose of the Haemophilus influenza, type B (Hib) vaccine.
Default PK <i>Non-compliant</i>	Student in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition with no doses of the Haemophilus influenza, type B (Hib) vaccine are non-compliant.
Deault <i>No Requirement</i>	All other state grades have no requirement for the Haemophilus influenza, type B (Hib) vaccine.
