#### **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days before the minimum interval or age are not considered valid and must be repeated as age-appropriate.

#### Meningococcal

1 dose 20-21 Compliant Active End Date: 06/30/2021	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 07, and  • the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.

1 dose 21-22 Compliant Active Start date: 07/1/2021 Active End date: 06/30/2022	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 07, 08, and  • the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.
1 dose 22-23 Compliant Active Start Date: 07/1/2022 Active End Date: 06/30/2023	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 07, 08, 09, and  • the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.
1 dose 23-24 Compliant Active State Date: 07/1/2024	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 07, 08, 09, 10, and  • the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.
2 dose 20-21 Compliant Active End Date: 06/30/2021	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 11,  • the student receives two dose of the Meningococcal (MCV4 or MenACWY) vaccine, and  • the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.
2 dose 21-22 & beyond Compliant Active Start Date: 7/1/2021	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 11, 12,  • the student receives two dose of the Meningococcal (MCV4 or MenACWY) vaccine, and  • the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.
1 dose at 16 Compliant	Students are considered compliant if the following conditions have been met:  • the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine, and  • the difference between the last dose and the birthdate is greater than 192 months with a 4 day tolerance.

No dose 20-21 Non-Compliant Active End Date: 6/30/2021	Students are considered non-compliant if the following conditions have been met:  • the student is in state grade: 07, 11, and  • the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.
No dose 21-22 Non-Compliant Active Start Date: 7/1/2021 Active End Date: 6/30/2022	Students are considered non-compliant if the following conditions have been met:  • the student is in state grade: 07, 08, 11, 12, and  • the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.
No dose 22-23 Non-Compliant Active Start Date: 7/1/2022 Active End Date: 6/30/2023	Students are considered non-compliant if the following conditions have been met:  • the student is in state grade: 07, 08, 09, 11, 12, and  • the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.
No dose 23-24 & beyond Non-Compliant Active Start Date: 7/1/2023	Students are considered non-compliant if the following conditions have been met:  • the student is in state grade: 07, 08, 09, 10, 11, 12, and  • the student has not received any doses of the Meningococcal (MCV4 or MenACWY) vaccine.

### **DTaP**

Rule	Requirements
5 dose K Compliant	Students are considered compliant when they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned with five doses of the DTaP/DTP combined vaccine.
4 dose PK Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition,</li> <li>they receive four doses of the DT, Td, DTaP/DTP, or Tdap vaccine.</li> </ul>

4 doses K-12 Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>they receive four doses of the DT, Td, DTaP/DTP, or Tdap vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.</li> </ul>
3 doses Td Compliant	Students are compliant when:  • they are in state grade(s) 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,  • they receive three doses of the Td or Tdap vaccine.
<b>Default</b> <i>Non-compliant</i>	N/A

# **Tdap**

Rule	Requirements
1 dose Grades 7-12 Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade(s): 07, 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the Td or Tdap vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
Grades 7-12 Default Non- compliant	Students are considered non-compliant if the following conditions have been met:  • the student is in state grade(s): 07, 08, 09, 10, 11, 12, and  • the student has not received any doses of the Td or Tdap vaccine.

## **Hepatitis B**

Students must have received **3 doses** of Hepatitis B to be considered compliant. The default setting is non-compliant.

1 MMR, 1M, 1M, 1R K-12 Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>they receive one dose of the MMR or MMRV vaccine, and</li> <li>they receive one dose of the Measles vaccine, or</li> <li>they receive one dose of the Mumps vaccine, or</li> <li>they receive one dose of the Rubella vaccine.</li> </ul>
2M, 2M, 2R K-12 Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>they receive two doses of the Measles vaccine, or</li> <li>they receive two doses of the Mumps vaccine, or</li> <li>they receive two doses of the Rubella vaccine.</li> </ul>

2 dos Varicella Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) KF: Full-time Kindergarten, KP: Part-time Kindergarten, or KT: Kindergarten Tuitioned, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>they receive two dose of the Varicella or MMRV vaccine.</li> </ul>

3 dose Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition,</li> <li>they receive three doses of the IPV, OPV, or IPV/OPV Polio vaccine.</li> </ul>
4 doses Compliant	Students are compliant when they receive four doses of the IPV, OPV, or IPV/OPV Polio vaccine.
3 doses OPV Compliant	<ul> <li>Students are compliant when:</li> <li>they receive three doses of the OPV or OPV/IPV Polio vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.</li> </ul>
3 doses IPV Compliant	<ul> <li>Students are compliant when:</li> <li>they receive three doses of the IPV or IPV/IPV Polio vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.</li> </ul>

## Hib

1 dose Compliant	<ul> <li>Students are compliant when:</li> <li>they are in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition,</li> <li>they receive one dose of the Haemophilus influenza, type B (Hib) vaccine.</li> </ul>
Default PK Non-compliant	Student in state grade(s) PK: Pre-Kindergarten, PK1: Pre-Kindergarten Part-Day, free, PK2: Pre-Kindergarten Part-Day, tuition, PK3: Pre-Kindergarten Full-Day, free, PK4: Pre-Kindergarten Full-Day, or PK5: Pre-Kindergarten Full-Day, partial tuition with no doses of the Haemophilus influenza, type B (Hib) vaccine are non-compliant.
<b>Deault</b> <i>No Requirement</i>	All other state grades have no requirement for the Haemophilus influenza, type B (Hib) vaccine.
