## Immunization Rules

The following tables describe all Michigan immunization requirements per vaccine.

### DTap

Rule	Requirements
<b>Age 0-1 month</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the DTaP vaccine.
<b>2-3 months</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old,</li> <li>the student is in state grade: 30: Early Childhood/Early On,</li> <li>the student receives one dose of the DTaP/DTP or DT vaccine.</li> </ul>

Rule	Requirements
<b>4-5 months</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 4 months, but no older than 5 months old,</li> <li>the student is in state grade: 30: Early Childhood/Early On,</li> <li>the student receives two doses of the DTaP/DTP or DT vaccine.</li> </ul>
<b>6-18 months</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 6 months, but no older than 18 months old,</li> <li>the student is in state grade: 30: Early Childhood/Early On,</li> <li>the student receives three doses of the DTaP/DTP or DT vaccine.</li> </ul>
<b>19 mos and older</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 19 months old,</li> <li>the student is in state grade: 30: Early Childhood/Early On,</li> <li>the student receives four doses of the DTaP/DTP or DT vaccine.</li> </ul>
<b>4-6 yrs</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 48 months, but no older than 83 months old,</li> <li>the student receives four doses of the DTaP/DTP or DT vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 0 (zero) day tolerance.</li> </ul>
<b>7 yrs and up</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months old,</li> <li>the student receives four doses of the DTaP/DTP, Tdap, Td, or DT vaccine.</li> </ul>
<b>7 yrs and up Td</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months old,</li> <li>the student receives three doses of the DTaP/DTP, Tdap, Td, or DT vaccine,</li> <li>the student receives one dose of the TD or Tdap vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 84 months with a 0 (zero) day tolerance.</li> </ul>

## Tdap

Rule	Requirements
<b>1 dose 11 yrs and older</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 132 months old,</li> <li>the student receives one dose of the Tdap vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 132 months with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose 11 yrs and older</b> <i>Non-compliant</i>	Students are considered non-compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 132 months old,</li> <li>the student receives one dose of the Tdap, DT, Td, or DTaP/DTP vaccine, and</li> <li>the difference between the last dose and the effective date is greater than or equal to 60 months with a 0 (zero) day tolerance.</li> </ul>

## Hepatitis B

Rule	Requirements
<b>Birth-1 mos</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Hepatitis B vaccine.
<b>2-3 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old,</li> <li>the student receives one dose of the Hepatitis B vaccine.</li> </ul>
<b>4-18 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 4 months, but no older than 18 months old,</li> <li>the student receives two doses of the Hepatitis B vaccine.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives three doses of the Hepatitis B vaccine.</li> </ul>
<b>2 doses</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Hepatitis B - 2 Dose vaccine.</li> </ul>

## MMR

## Measles-Mumps-Rubella

Rule	Requirements
<b>Birth - 15 mos</b> <i>No Requirement</i>	Students 15 months old and younger are not required to receive any doses of the Measles/Mumps/Rubella vaccine.
<b>16 mos - 4 yrs</b> <b>MMR</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 16 months, but no older than 47 months old,</li> <li>• the student receives one dose of the MMR or MMRV vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul>
<b>16 mos - 4 yrs</b> <b>M,M,R</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 16 months, but no older than 47 months old,</li> <li>• the student receives one dose of the Measles vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> </ul>               OR             </li> <li>• the student receives one dose of the Mumps vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> </ul>               OR             </li> <li>• the student receives one dose of the Rubella vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul> </li> </ul>
<b>4 yrs and up</b> <b>MMR</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 48 months old,</li> <li>• the student receives two doses of the MMR or MMRV vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>4 yrs and up M,M,R</b>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months old,</li> <li>• the student receives two doses of the Measles vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> <li>OR</li> </ul> </li> <li>• the student receives two doses of the Mumps vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> <li>OR</li> </ul> </li> <li>• the student receives two doses of the Rubella vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul> </li> </ul>
<b>4 yrs and up 1MMR, 1M, 1M, 1R</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months old,</li> <li>• the student receives one dose of the MMR or MMRV vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> <li>AND</li> </ul> </li> <li>• the student receives one dose of the Measles vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> <li>OR</li> </ul> </li> <li>• the student receives one dose of the Mumps vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance,</li> <li>OR</li> </ul> </li> <li>• the student receives one dose of the Rubella vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul> </li> </ul>

## Varicella

Rule	Requirements
<b>Birth - 15 mos</b> <i>No Requirement</i>	<p>Students 15 months old and younger are not required to receive any doses of the Varicella vaccine.</p>

Rule	Requirements
<b>16 mos and older</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 16 months old,</li> <li>the student receives one dose of the Varicella or MMRV vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul>
<b>2 doses</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Varicella or MMRV vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul>

## Polio

Rule	Requirements
<b>Birth - 1 mo</b> <i>Compliant</i>	Students 1 month old and younger are not required to receive any doses of the Polio vaccine.
<b>2-3 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old, and</li> <li>the student receives one dose of the IPV/OPV, IPV, or OPV Polio vaccine.</li> </ul>
<b>4-18 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 4 months, but no older than 18 months old, and</li> <li>the student receives two doses of the IPV/OPV, IPV, or OPV Polio vaccine.</li> </ul>
<b>19 mos and older</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 19 months old,</li> <li>the student is in state grade: 30: Early Childhood/Early On, and</li> <li>the student receives three dose of the IPV/OPV, IPV, or OPV Polio vaccine.</li> </ul>

Rule	Requirements
<b>4-6 yrs</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 48 months, but no older than 72 months old,</li> <li>the student receives three doses of the IPV/OPV, IPV, or OPV Polio vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 0 (zero) day tolerance.</li> </ul>
<b>7 yrs and up</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months old, and</li> <li>the student receives three doses of the IPV/OPV, IPV, or OPV Polio vaccine.</li> </ul>

## Pneumococcal

Rule	Requirements
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Pneumococcal vaccine.
<b>1 dose 2-3 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old, and</li> <li>the student receives one dose of the Pneumococcal PCV or PPV vaccine.</li> </ul>
<b>2 dose 4-5 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 4 months, but no older than 5 months old, and</li> <li>the student receives two doses of the Pneumococcal PCV or PPV vaccine.</li> </ul>
<b>3 dose 6-15 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 6 months, but no older than 15 months old, and</li> <li>the student receives three doses of the Pneumococcal PCV or PPV vaccine.</li> </ul>

Rule	Requirements
<b>4 dose 16 mos and older</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 16 months, and</li> <li>the student receives four doses of the Pneumococcal PCV or PPV vaccine.</li> </ul>
<b>1 dose 24 mos - 4 yrs</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 24 months, but no older than 48 months old,</li> <li>the student receives one dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>the difference between first dose and the student's birthdate is greater than or equal to 24 months with a 0 (zero) day tolerance.</li> </ul>
<b>Age 5 yrs and older</b> <i>No Requirement</i>	Students 60 months old and older are not required to receive any doses of the Pneumococcal vaccine.

## HIB

Rule	Requirements
<b>Birth - 1 mo</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Hib vaccine.
<b>2-3 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old, and</li> <li>the student receives one dose of the Haemophilus influenza, type B (Hib) vaccine.</li> </ul>
<b>4-15 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 4 months, but no older than 15 months old, and</li> <li>the student receives two dose of the Haemophilus influenza, type B (Hib) vaccine.</li> </ul>



Rule	Requirements
<b>16 mos - 4 yrs - 1 dose &gt;= 15 mos</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 16 months, but no older than 48 months old,</li> <li>the student receives one dose of the Haemophilus influenza, type B (Hib) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 15 months with a 0 (zero) day tolerance.</li> </ul>
<b>16 mos - 4 yrs</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 16 months, but no older than 59 months old, and</li> <li>the student receives two doses of the Haemophilus influenza, type B (Hib) vaccine.</li> </ul>
<b>5 yrs and up</b> <i>No Requirement</i>	Students 60 months old and older are not required to receive any doses of the Hib vaccine.

## Meningococcal

Rule	Requirements
<b>1 dose 11-18 yrs</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 132 months, but no older than 216 months old,</li> <li>the student is in state grade(s): 06, 07, 08, 09, 10, 11, 12, and</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>1 dose 11 yrs and older</b> <i>Non-compliant</i>	Students are considered non-compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 132 months, but no older than 216 months old,</li> <li>the student is in state grade(s): 06, 07, 08, 09, 10, 11, 12, and</li> <li>the student has received no doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
