The CTE Data Collections extract reports students in state grades 09 - 12 enrolled in a CTE Program. Students report once per CTE Program in which they are enrolled when the Report Type is Enrollment File. They only report once when the Report Type is Outcome File.

Report Logic

- Reports all students that meet **both** of the following:
 - Enrolled in state grade 09-12 (any enrollment type) at any time from the extract editor start date through the extract editor end date.
 - $\circ~$. Enrolled in a CTE program from the extract editor start date to the extract editor end date.
 - Program Admin > Academic Programs > Program Type = CTE
- Enrollment File
 - Reports one record per student, per CTE active program within extract editor start and end dates.
 - Reports one record per unique course/CIP code combination.
- Outcome File
 - Students only report one time.
 - If a student has more than one CTE program, the most recent CTE Program information reports.
 - If the student has more than one CTE program with the same start and end dates, the program with the highest ID reports.



Report Editor Fields

Field	Description
Report Type	Enrollment File: Students report once per CTE Program in which they are enrolled.Outcome File: Students only report one time.
Start Date	The Start Date of the testing window. Students must be enrolled during the testing window date range.
End Date	The End Date of the testing window. Students must be enrolled during the testing window date range.
Run Date	Defaults to the current date.
File Identifier	The submission number.
Format	The format in which the report generates:CSV (State Format)HTMLTXT
Exclude Cross-Site Data	 Cross-site section enrollment data is <u>not</u> included in the report when checked. Cross-site enrollment functionality must be enabled at the district level for the checkbox to display. Defaults to checked.

Select Calendars	The calendar(s) from which data is pulled for the report.
Generate Report	The report appears in a separate window in the designated format.
