



This collection captures student-level information for the entire school year and includes student demographics, P-TECH year of enrollment, CIP information, and CTE course enrollment information.



Report Logic

- Reports a record for each unique CTE CIP Code/Course combination for all P-TECH students.
- To report, a student must have an enrollment in at least one of the selected calendars and their enrollment
 - Start Date is less than or equal to the extract editor Effective Date.
 - Service Type is Primary, Partial or Special Ed Services. (Data reports from the most recent Primary enrollment. If no Primary enrollment exists, the most recent enrollment is used.)
 - **Grade** is mapped to a **State Grade Level Code** of 09-12.
- To report, a student must have at least one CTE Program Participation record where all of the following are met:
 - CTE Start Date is before the extract editor's Effective Date.



- CTE **End Date** is NULL or after the Calendar **Start Date**.
- The record must be associated with a CTE Program in which the State Code (CIP) is not NULL, the State Reported is marked, and the **P-TECH Indicator** is marked.
- If the student is scheduled in a CTE Course, a record reports when all of the following statements are true.
 - Course is associated with the Calendar selected on the extract editor.
 - Roster **Start Date** is before or equal to the extract editor Effective Date.
 - Course StateCode is not NULL.
 - Course is Active.
 - Course Number matches a CTE Course Requirement's Transcript/Course Number and is associated with the CTE State Code (CIP) of one of the student's CTE records.
 - If there are multiple Roster records for a single course, a distinct record for each Course reports.
 - If the student is not scheduled in any P-TECH courses, a record reports for the CTE Program and the course data elements will be blank.
- Students are NOT included if their:
 - enrollment record is marked as State Exclude;
 - Course is marked as Exclude:
 - o Grade Level of enrollment is marked as State Exclude; or
 - Calendar of enrollment is marked as State Exclude. This requirement does NOT apply to Summer School calendars.

Report Editor Fields

Field	Description
Report Type	Determines which P-TECH file is generated.
Effective Date	Data is pulled as of the date selected in this field.
Run Date	The date when the report was generated. This date appears in the Submission Date field on the report.
File Identifier	Uniquely identifies the individual submission.
Exclude Cross-Site Data	 Cross-site section enrollment data is <u>not</u> included in the report when checked. <u>Cross-site enrollment</u> functionality must be enabled at the district level for the checkbox to display. Defaults to checked.
State Grade Level	Determines specific grades to include in the report. Only grade levels from schools active during the report date range display.



Field	Description
Ad Hoc Filter	Select a filter to limit results to students included in the filter.
Format	Determines the format for the report. • CSV (Comma Separated) • TXT (Fixed Width State Format) • HTML
Select Calendars	The calendar(s) from which data is pulled for the report.
Generate Extract	The report appears in a separate window in the designated format.
Submit to Batch	This process allows larger reports to be generated in the background without disrupting the use of Campus. See the Batch Queue article for more information about submitting a report to the batch queue.

The student does not report If they dropped the course within the first 5 instructional days of the term when the course began. All others report blank.
