<b>NGA Cohort End Year</b>	This field is used as part of the National Governor’s Association graduation calculation rate. The selected year is often four years after the ninth grade start year; if a student has not graduated high school in four years (could be less than or more than four years), this selection can be changed. <b>NCLB Cohort End Year</b>	Read-only field that is auto-populated when the Date First Entered the 9th Grade field is set. Shows the expected year of graduation for the student for use in NCLB calculations. <b>This field cannot be edited</b>	Student > Learner > Graduation Elements > <b>graduation.cohortYearNCLB</b>
<b>Post Grad Intended Location</b>	Selection indicates where the student is participating in after-high school activities, either IS: In-State or OS: Out-of-State.
