## Report Logic

- A record is reported for each disciplinary action that results in a student's removal from any part of their regular academic program.

- A single student will have multiple records if removed from their classroom more than once.
- Reported records are not based on whether or not a student has a Resolution Date entered that falls within the current school year. Records under this scenario would still be reported as the incident occurred within the reporting school year.
- Every disciplinary action that results in the removal of a student from any part of their regular academic program must be categorized as one of the following: In-School Suspension (ISS), Out of School Suspension (OOS), Expulsion, Juvenile Justice Alternative Education Program (JJAEAP) or DAEP assignments.
- A record is reported for every behavior event with a 2-digit resolution code that occurred during the reporting school year. Resolution codes greater than 2 characters are not reported.
- To report, a Behavior record must have an entry in the Role field for the Role of Offender or Participant.
- If a student's enrollment has a Service Type of P, Primary, and a Service Type of S or N, data from the student's P (Primary) enrollment reports. If a student does not have a P, Primary, enrollment, then the enrollment that has a Service type of S or N that meets ALL other criteria reports.
- Summer School Enrollment data is not reported.

**Students who meet the following criteria are NOT reported:**

- Students with an ADA Eligibility = 0 or blank.
- Students with no State ID.
- Students marked as State Exclude, in a grade level marked State Exclude, or enrolled in a calendar marked State Exclude.
- Students marked No Show.

[Attendance Periods](#) must be created for calendar information to be considered in state reporting.

<b>Effective Date</b>	Only data as of this date reports. The default value is the current date.

<b>Report Type</b>	XML
<b>Filter By</b>	This field allows you to narrow the report results to specific Calendars, Calendar Years (District), or Schools.

Field	Description
<b>Population</b>	This option allows you to limit report results to Unique IDs. The Unique ID option only considers students with a Unique ID, while the <i>All</i> option considers all students.
<b>Ad Hoc Filter</b>	Select an Ad Hoc filter to limit report results to those that meet filter requirements.
<b>Report Generation</b>	The report can be marked to generate immediately using the <b>Generate Extract</b> button or can be marked to generate at a later time using the <b>Submit to Batch</b> button. See the <a href="#">Batch Queue</a> article for additional guidance.
