# Report Logic

## Vaccine Exemptions/Waivers

Waivers must be mapped to a State Exemption Code. When waivers are assigned to students but not mapped to a state exemption code, the report does not calculate accurately.

Exemptions are pulled from the Vaccine Exemption Code. Only these Exemption Codes are recognized.

- M: Medical
- R: Religious
- C: Per Conv
- H: Hx/Dis for Varicella Only

## State Exclude

The following State Exclude logic pertains to the Local Health Department Report:

- A student enrolled in a grade level marked as state exclude is not included on the report.
- A student enrolled in a calendar marked as state exclude is not included on the report.

## Student Population

Students can only count in one row per vaccine. Meningococcal counts are only for 7th- and 12th-grade students.

A count is tallied in each of the following areas:

Compliance Status	Description
<b>Meets all minimum requirements</b>	Reports a total of all students in the grade grouping being reported who have a compliance of <i>Compliant</i> , <i>No Requirement</i> , <i>Lab Conf</i> or do not have applicable rules for all vaccines and have a dose of any vaccine.
<b>In process</b>	Reports a total of all students in the grade grouping being reported who have a compliance status of <i>In Process</i> for any vaccine and no vaccines with a compliance state of <i>Non-Compliant</i> and have a dose of any vaccine.
<b>Behind Schedule</b>	Reports a total of all students in the grade grouping being reported who have a compliance status of <i>Non-Compliant</i> for any vaccine or have a waiver for any vaccine with a name other than <i>Hx/Dis</i> , <i>Religious</i> , <i>Health</i> , <i>Lab Conf</i> or <i>Per Conv</i> and have a dose of any vaccine. Students who have no doses of any vaccine but do have an immunization record also report as <i>Behind Schedule</i> .
<b>Health waiver</b>	Reports a total of all students in the grade grouping being reported who have a status of <i>Exempt - Health</i> for any vaccine and do not have a status of <i>Non-Compliant</i> or <i>In-Process</i> for any vaccine.

Compliance Status	Description
<b>Religious waiver</b>	Reports a total of all students in the grade grouping being reported who have a status of <i>Exempt - Religious</i> for any vaccine and do not have a status of <i>Non-Compliant</i> , <i>Exempt - Health</i> or <i>In-Process</i> for any vaccine.
<b>Personal conviction waiver</b>	Reports a total of all students in the grade grouping being reported who have a status of <i>Exempt - Per Conv</i> for any vaccine and do not have a status of <i>Non-Compliant</i> , <i>Exempt - Health</i> , <i>Exempt - Religious</i> or <i>In Process</i> for any vaccine.
<b>No Record</b>	Reports a total of all student in the grade grouping being reported who have not received a dose of the selected vaccine and does NOT have a waiver.
<b>History of Varicella Disease</b> <i>Varicella Only</i>	Reports a total of students with an <i>Exempt - Hx/DIS</i> waiver for Varicella.
<b>Vaccine Total</b>	Reports the sum of the above compliance statuses per vaccine.

## Report Editor

The following fields are available for entry on the Local Health Department Report.

Field	Description
<b>Effective Date</b>	Entered date returns only those students actively enrolled on that date. Dates are entered in <i>mmddyy</i> format or can be chosen by clicking the calendar icon.
<b>Format</b>	The Local Health Department Report can be generated in either HTML or CSV. Data returned on the HTML or Comma Delimited output is then entered into a F-04002 form (available from DPI) for each school.
<b>Ad hoc Filter</b>	Selecting an Ad hoc Filter returns only those students who are included in that filter and meet the reporting requirements of the report itself.
<b>Calendar Selection</b>	<p>Indicates from which calendar of enrollment information is reported. The calendar chosen in the Campus toolbar is automatically selected. The report can be generated for one school at a time, or a set of schools at a time (all elementary schools, for example). At least one calendar needs to be selected. Calendars can be listed by the Active Year, by School name or by Year.</p> <p>Note that when more than one calendar is selected, the report must be submitted to the batch for generation. It is recommended that users do not select all schools in the district at one time.</p>

Field	Description
<b>Report Generation</b>	The report can be generated immediately using the <b>Generate Extract</b> button. When there is a larger amount of data chosen (several calendars, large date range, etc.), use the <b>Submit to Batch</b> button, which allows the user to choose when the report is generated. See the <a href="#">Batch Queue</a> article for more information.

## Generate the Report

1. Enter the **Effective Date**.
2. Select the desired **Format** of the report.
3. If desired, select an **Ad hoc Filter**.
4. Select the **Calendars** to include in the report.
5. Select the **Generate Extract** button or use the **Submit to Batch** option. The report displays in a separate window in the designated format.

<b>Section D</b> Section D displays the summary totals at the bottom of the report in rows 12-17.
