Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Nebraska Department of Health.

## **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days before the minimum interval or age are not considered valid and must be repeated as age-appropriate.

### **Hepatitis B**

- Students between the ages of 2 and 5 years who are enrolled in a school based program are required to have **3 doses** of the pediatric Hepatitis B vaccine.
- Students entering school for the first time (K or 1st), students entering 7th grade and transfer students from outside Nebraska (regardless of grade) are required to have **3 doses** of the pediatric Hepatitis B vaccine OR **2 doses** of the adolescent vaccine if between the ages of 11 and 15 years.
- Students not described above (grades 1-6 and 8-12) are required to have **3 doses** of the pediatric Hepatitis B vaccine OR **2 doses** of the adolescent vaccine if between the ages of 11 and 15 years.

### DTaP

Td, Tdap, DT and DTAP vaccines are also acceptable for these requirements.

<b>Under 2</b> years No Requirement	Students 23 months old and younger are not required to receive any doses of the DTaP vaccine.
<b>3 doses</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives three doses of the DTaP vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>K-12</b> <i>Non-</i> <i>Compliant</i>	<ul> <li>Students are considered non-compliant if the following conditions have been met:</li> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and</li> <li>the student has received no doses of the DTaP vaccine.</li> </ul>
<b>2-5 years</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 24 months, but no older than 71 months old, and</li> <li>the student receives four doses of the DTaP vaccine.</li> </ul>

# Tdap

Rule	Requirements
<b>1 dose 8-12</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the Tdap vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>1 dose 7th</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: 07,</li> <li>the student receives one dose of the Tdap vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>No dose 7- 12</b> <i>Non-</i> <i>compliant</i>	<ul> <li>Students are considered non-compliant if the following conditions have been met:</li> <li>the student is in state grade: 07, 08, 09, 10, 11, 12, and</li> <li>the student has not received any doses of the Tdap vaccine.</li> </ul>

## Hib

Rule	Requirements
<b>K(after age 5)</b> - 12 No Requirement	<ul> <li>Students who meet the following conditions are not required to receive any doses of the Hib vaccine:</li> <li>the student is at least 61 months old, and</li> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12.</li> </ul>
<b>2-4 years - 3</b> <b>doses</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is 24 months, but no older than 59 months old, and</li> <li>the student receives three doses of the Hib vaccine.</li> </ul>
2-4 years - 1 dose after 15 mos Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is 24 months, but no older than 59 months old,</li> <li>the student receives one dose of the Hib vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 15 months with a 4 day tolerance.</li> </ul>
<b>2-4 years</b> Non-Compliant	<ul> <li>Students are considered non-compliant if the following conditions have been met:</li> <li>the student is 24 months, but no older than 59 months old, and</li> <li>the student receives no doses of the Hib vaccine.</li> </ul>

## MMR

Rule	Requirements
-	Students 23 months old and younger are not required to receive any doses of the MMR vaccine.

<b>2 doses MMR</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two doses of the MMR or MMRV vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
2 doses M,M,R Compliant	<ul> <li>Students are considered compliant if the following conditions have been met: <ul> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two doses of the Measles vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> </ul> </li> <li>the student receives two doses of the Mumps vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the student receives two doses of the Mumps vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the student receives two doses of the Rubella vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> </ul>

<b>2 doses - Mix</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two doses of the Measles vaccine and MMR or MMRV vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> </ul> </li> <li>the student receives two doses of the Mumps vaccine and MMR or MMRV vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the student receives two doses of the Mumps vaccine and MMR or MMRV vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> </ul> </li> <li>the student receives two doses of the Rubella vaccine and MMR or MMRV vaccine, and <ul> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> </ul>

<b>2-5 years -</b> <b>MMR</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 24 months, but no older than 71 months old,</li> <li>the student receives one dose of the MMR or MMRV vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>2-5 years -</b> <b>M,M,R</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 24 months, but no older than 71 months old,</li> <li>the student receives one dose of the Measles vaccine, and <ul> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the student receives one dose of the Mumps vaccine, and <ul> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the student receives one dose of the Mumps vaccine, and <ul> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> <li>the student receives one dose of the Rubella vaccine, and <ul> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> </ul> </li> </ul>

# Varicella

- Students between the ages of 2 and 5 who are enrolled in a school based program are required to have **1 dose** of varicella or MMRV given on or after 12 months of age. Written documentation (including year) of varicella disease from parent, guardian or health care provider will be accepted.
- Students entering school for the first time (K or 1st), students entering 7th grade and transfer students from outside Nebraska (regardless of grade) are required to have 1 dose of varicella or MMRV if given on or after 12 months of age and prior to 13 years of age (end 6/30/2011). If given over 13 years of age, 2 doses of varicella (not MMRV) are required, separated by at least one month. Written documentation (including year) of varicella disease from parent, guardian or health care provider will be accepted.
- Students not described above (grades 1-6 and 8-12) are required to have **1 dose** of varicella. Written documentation (including year) of varicella disease from parent, guardian or health care provider will be accepted.

# Polio

All students are required to have **3 doses** of the polio vaccine.

### Pneumococcal

Rule	Requirements
<b>Default K (after age 5) - 12</b> <i>No Requirement</i>	<ul> <li>Students are not required to receive any doses of the Pneumococcal PCV or PPV vaccine if the following conditions have been met:</li> <li>the student is at least 61 months old, and</li> <li>the student is in state grade: HK: Kindergarten prog of &lt;1032 instructional prog hrs, KG: Kindergarten 1032 or more instructional prog hours, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12.</li> </ul>



Rule	Requirements
Default over 59 months No Requirement	Students 60 months old and older are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.
<b>Default under</b> <b>24 months</b> <i>No Requirement</i>	Students 23 months old and younger are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.
<b>1 dose</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student receives one dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 15 months with a 4 day tolerance.</li> </ul>
<b>4 doses</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student receives four doses of the Pneumococcal PCV or PPV vaccine.</li> </ul>
