The following information describes vaccine compliance rules as defined by the Oklahoma State Department of Health.

#### **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age shall be counted as valid.
- Doses administered 5 days earlier than the minimum interval or age shall not be counted as valid doses and shall be repeated as age-appropriate.

#### **DTaP**

4 doses PK Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: PR: Preschool, PK3F: Pre-Kindergarten Fullday 3-year-old, PK3H: Pre-Kindergarten Half-day 3-year-old, PK4F: Pre-Kindergarten Full-day, PK4H: Pre-Kindergarten Half-day,</li> <li>the student receives four doses of the DT, Td, Tdap, or DTaP combined vaccine,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than or equal to 28 days with a 4 day tolerance, and</li> <li>the difference between the fourth and previous dose is greater than or equal to 4 months with a 4 day tolerance.</li> </ul>
5 doses Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>The student is in state grade: KG: Kindergarten Full-day, KG/H: Kindergarten Half-day,01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, TK: Transitional Kindergarten.</li> <li>The student receives five doses of the DT, Td, Tdap, or DTaP combined vaccine,</li> <li>The difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> <li>The difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> <li>The difference between the fourth and previous dose is greater than or equal to 4 months with a 4-day tolerance.</li> <li>The difference between the fifth and previous dose is greater than or equal to 6 months with a 4-day tolerance.</li> <li>The difference between the fifth dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.</li> </ul>
4 doses Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>The student is in state grade: KG: Kindergarten Full-day, KG/H: Kindergarten Half-day,01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, TK: Transitional Kindergarten.</li> <li>The student receives four doses of the DT, Td, Tdap, or DTaP combined vaccine.</li> <li>The difference between the last dose and the student's birthdate is greater than 48 months with a 4-day tolerance.</li> <li>The difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> <li>The difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> <li>The difference between the fourth and previous dose is greater than or equal to 4 months with a 4-day tolerance.</li> </ul>

7+ catch Up In Progress	<ul> <li>Students are considered in progress if the following conditions have been met:</li> <li>the student is at least 84 months old,</li> <li>the student receives three doses of the DT, DTap-DTP, Td, or Tdap vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance, and</li> <li>the difference between the third and previous dose is greater than or equal to 6 months with a 4 day tolerance.</li> </ul>

## **Hepatitis A**



Rule	Requirements
No Requirement No Requirement	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Hepatitis A vaccine.
2 doses Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student receives two doses of the Hepatitis A vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 6 months with a 4 day tolerance.</li> </ul>

#### **Varicella**



Rule	Requirements
No Requirement No Requirement	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Varicella vaccine.
1 dose Compliant	<ul> <li>Students are considered compliant when:</li> <li>The student receives one dose of the Varicella or MMRV vaccine.</li> <li>The difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>

# **Hepatitis B**

No Requirement No Requirement	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Hepatitis B vaccine.
3 doses Compliant	Students are considered compliant if the following conditions have been met:  • the student receives three doses of the Hepatitis B vaccine.
2 doses Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student receives two doses of the Hepatitis B vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 132 months with a 4 day tolerance, and</li> <li>the difference between the second dose and the student's birthdate is greater than 6 months with a 4 day tolerance.</li> </ul>

#### **MMR**



Rule	Requirements
No Requirement No Requirement	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the MMR vaccine.
2 MMR Compliant	Students are considered compliant if the following conditions have been met:  • the student receives two doses of the MMR or MMRV vaccine,  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and  • the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.

2 M,M,R Compliant	Students are considered compliant if the following conditions have been met:  • the student receives two doses of the Measles vaccine,  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and  • the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,  • the student receives two doses of the Mumps vaccine,  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and  • the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,  • the student receives two doses of the Rubella vaccine,  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and  • the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.

1 M,M,R Compliant	Students are considered compliant if the following conditions have been met:  • the student is in state grade: PR: Preschool, PK3F: Pre-Kindergarten Full-day 3-year-old, PK3H: Pre-Kindergarten Half-day 3-year-old, PK4F: Pre-Kindergarten Full-day, PK4H: Pre-Kindergarten Half-day,  • the student receives one dose of the Measles vaccine, and  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,  • the student receives one dose of the Mumps vaccine, and  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,  • the student receives one dose of the Rubella vaccine, and  • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance.
1 dose MMR In Progress In Process	Students are considered in process if the following conditions have been met:  • the student receives one dose of the MMR or MMRV vaccine, and  • the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.
1 dose M,M,R In Progress In Process	Students are considered in process if the following conditions have been met:  • the student receives one dose of the Measles vaccine, and  • the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance,  • the student receives one dose of the Mumps vaccine, and  • the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance,  • the student receives one dose of the Rubella vaccine, and  • the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.

#### **Polio**



Rule	Requirements
No Requirement No Requirement	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Polio vaccine.
4 doses Compliant OPV End Date: 04/01/2016	Students are considered compliant if the following conditions have been met:  • the student receives four doses of the IPV, OPV, or IPV/OPV combined vaccine.
3 doses Compliant OPV End Date: 04/01/2016	Students are considered compliant if the following conditions have been met:  • the student receives three doses of the IPV, OPV, or IPV/OPV combined vaccine, and  • the difference between the last dose and the student's birthdate is greater than 48 months with a 4 day tolerance.
3 doses PK and younger Compliant OPV End Date: 04/01/2016	Students are considered compliant if the following conditions have been met:  • the student is in state grade: PR: Preschool, PK3F: Pre-Kindergarten Full-day 3-year-old, PK3H: Pre-Kindergarten Half-day 3-year-old, PK4F: Pre-Kindergarten Full-day, PK4H: Pre-Kindergarten Half-day, and  • the student receives three doses of the IPV, OPV, or IPV/OPV combined vaccine.

# **Tdap**

Rule	Requirements
1 dose Compliant	Students are considered compliant if the following conditions have been met:  • the student is in state grade: 07, 08, 09, 10, 11, 12, and  • the student receives one dose of the Tdap vaccine.
Grades 7-12 Non-Compliant Active Start Date: 07/01/2011	Students in state grade: 07, 08, 09, 10, 11, 12, with no doses of the Tdap vaccine are considered non-compliant.
