General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age shall be counted as valid.
- Doses administered 5 days earlier than the minimum interval or age shall not be counted as valid doses and shall be repeated as age-appropriate.

DTaP

4 doses PK <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: PR: Preschool, PK3F: Pre-Kindergarten Full-day 3-year-old, PK3H: Pre-Kindergarten Half-day 3-year-old, PK4F: Pre-Kindergarten Full-day, PK4H: Pre-Kindergarten Half-day, the student receives four doses of the DT, Td, Tdap, or DTaP combined vaccine, the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance, the difference between the third and previous dose is greater than or equal to 28 days with a 4 day tolerance, and the difference between the fourth and previous dose is greater than or equal to 4 months with a 4 day tolerance.
5 doses <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> The student is in state grade: KG: Kindergarten Full-day, KG/H: Kindergarten Half-day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, TK: Transitional Kindergarten. The student receives five doses of the DT, Td, Tdap, or DTaP combined vaccine, The difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance. The difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance. The difference between the fourth and previous dose is greater than or equal to 4 months with a 4-day tolerance. The difference between the fifth and previous dose is greater than or equal to 6 months with a 4-day tolerance. The difference between the fifth dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.
4 doses <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> The student is in state grade: KG: Kindergarten Full-day, KG/H: Kindergarten Half-day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, TK: Transitional Kindergarten. The student receives four doses of the DT, Td, Tdap, or DTaP combined vaccine. The difference between the last dose and the student's birthdate is greater than 48 months with a 4-day tolerance. The difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance. The difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance. The difference between the fourth and previous dose is greater than or equal to 4 months with a 4-day tolerance.

Rule	Requirements
7+ catch Up <i>In Progress</i>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> • the student is at least 84 months old, • the student receives three doses of the DT, DTaP-DTP, Td, or Tdap vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance, and • the difference between the third and previous dose is greater than or equal to 6 months with a 4 day tolerance.

Hepatitis A



Rule	Requirements
No Requirement <i>No Requirement</i>	<p>Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Hepatitis A vaccine.</p>
2 doses <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> • the student receives two doses of the Hepatitis A vaccine, • the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and • the difference between the second and previous dose is greater than 6 months with a 4 day tolerance.

Varicella



Rule	Requirements
No Requirement <i>No Requirement</i>	<p>Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Varicella vaccine.</p>
1 dose <i>Compliant</i>	<p>Students are considered compliant when:</p> <ul style="list-style-type: none"> • The student receives one dose of the Varicella or MMRV vaccine. • The difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.
Default <i>Non-compliant</i>	<p>N/A</p>



Hepatitis B

Rule	Requirements
No Requirement <i>No Requirement</i>	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Hepatitis B vaccine.
3 doses <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none">the student receives three doses of the Hepatitis B vaccine.
2 doses <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none">the student receives two doses of the Hepatitis B vaccine,the difference between the first dose and the student's birthdate is greater than 132 months with a 4 day tolerance, andthe difference between the second dose and the student's birthdate is greater than 6 months with a 4 day tolerance.

MMR



Rule	Requirements
No Requirement <i>No Requirement</i>	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the MMR vaccine.
2 MMR <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none">the student receives two doses of the MMR or MMRV vaccine,the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, andthe difference between the second and previous dose is greater than 28 days with a 4 day tolerance.

2 M,M,R <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> • the student receives two doses of the Measles vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and ◦ the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, • the student receives two doses of the Mumps vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and ◦ the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, • the student receives two doses of the Rubella vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and ◦ the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.

1 dose M,M,R In Progress <i>In Process</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> the student receives one dose of the Measles vaccine, and <ul style="list-style-type: none"> the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance, the student receives one dose of the Mumps vaccine, and <ul style="list-style-type: none"> the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance, the student receives one dose of the Rubella vaccine, and <ul style="list-style-type: none"> the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.

Polio

No Requirement <i>No Requirement</i>	Students in state grades AE: Adult Education or UG: Ungraded are not required to receive any doses of the Polio vaccine.
4 doses <i>Compliant</i> <i>OPV End Date:</i> <i>04/01/2016</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student receives four doses of the IPV, OPV, or IPV/OPV combined vaccine.
3 doses <i>Compliant</i> <i>OPV End Date:</i> <i>04/01/2016</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student receives three doses of the IPV, OPV, or IPV/OPV combined vaccine, and the difference between the last dose and the student's birthdate is greater than 48 months with a 4 day tolerance.
3 doses PK and younger <i>Compliant</i> <i>OPV End Date:</i> <i>04/01/2016</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: PR: Preschool, PK3F: Pre-Kindergarten Full-day 3-year-old, PK3H: Pre-Kindergarten Half-day 3-year-old, PK4F: Pre-Kindergarten Full-day, PK4H: Pre-Kindergarten Half-day, and the student receives three doses of the IPV, OPV, or IPV/OPV combined vaccine.

Tdap

Rule	Requirements
1 dose <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 10, 11, 12, and the student receives one dose of the Tdap vaccine.
Grades 7-12 <i>Non-Compliant</i> <i>Active Start Date:</i> <i>07/01/2011</i>	<p>Students in state grade: 07, 08, 09, 10, 11, 12, with no doses of the Tdap vaccine are considered non-compliant.</p>
