## General Compliance Rules

There is a 4 day grace period for deadlines of a dose. Doses administered 5 days earlier than the minimum interval will not be counted as valid doses and should be repeated as age appropriate.

## Hepatitis B

<b>2 mos</b> <i>No Requirement</i>	Students 2 months old and younger are not required to receive any doses of the Hepatitis B vaccine.
<b>3 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 3 months, but no older than 4 months old, and</li> <li>• the student receives one dose of the Hepatitis B vaccine.</li> </ul>
<b>5 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months, but no older than 18 months old, and</li> <li>• the student receives two doses of the Hepatitis B vaccine.</li> </ul>
<b>19 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 19 months old, and</li> <li>• the student receives three doses of the Hepatitis B vaccine.</li> </ul>
<b>Between doses 1-2</b> <i>In Process</i>	<p>Students are considered in process when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the Hepatitis B vaccine, and</li> <li>• the difference between the first dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

# DTaP

Td, Tdap, DT, and DTaP vaccines are acceptable for these requirements.

<b>5 doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives five doses of the DTaP vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<b>4 doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives four doses of the DTaP vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives three doses of the DTaP vaccine,</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance, and</li> <li>the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 0 (zero) day tolerance.</li> </ul>

<b>Default for K-12</b> <i>Non-compliant</i>	<p>Students are considered non-compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and</li> <li>• the student has not received any doses of the DTaP vaccine.</li> </ul>
<b>2 mos</b> <i>No Requirement</i>	<p>Students 2 months old and younger are not required to receive any doses of the DTaP vaccine.</p>
<b>3 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 3 months, but no older than 4 months old, and</li> <li>• the student receives one dose of the DT or DTaP vaccine.</li> </ul>

Rule	Requirement
<b>5 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 5 months, but no older than 6 months old, and</li> <li>the student receives two doses of the DT or DTaP vaccine.</li> </ul>

<b>1 Dose 7-12</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade(s): 07, 08, 09, 10, 11, 12, and</li> <li>the student receives one dose of the Td, or Tdap vaccine.</li> </ul>
<b>Default 7-12</b> <i>Non-compliant</i>	<p>Students are considered non-compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade(s): 07, 08, 09, 10, 11, 12, and</li> <li>the student has not received any doses of the Td, or Tdap vaccine.</li> </ul>

## Hib

Haemophilus influenza, type B (Hib)

<b>60 months and older</b> <i>No Requirements</i>	<p>Students 60 months old and older are not required to receive any doses of the Hib vaccine.</p>
<b>2 mos</b> <i>No Requirements</i>	<p>Students 2 months old and younger are not required to receive any doses of the Hib vaccine.</p>
<b>3 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 3 months, but no older than 4 months old, and</li> <li>the student receives one dose of the Hib vaccine.</li> </ul>

Rule	Requirements
<b>5 mos</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months, but no older than 15 months old, and</li> <li>• the student receives two doses of the Hib vaccine.</li> </ul>

<b>After 16 mos, 1MMR</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 16 months old, and</li> <li>the student receives one dose of the MMR or MMRV vaccine.</li> </ul>

Rule	Requirements
<b>After 16 mos</b> <b>1M,M,R</b> <i>Compliant</i>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 16 months old, and</li> <li>• the student receives one dose of the Measles vaccine, OR</li> <li>• the student receives one dose of the Mumps vaccine, OR</li> <li>• the student receives one dose of the Rubella vaccine.</li> </ul>

## Varicella

A note from a parent or doctor indicating that the student had the disease is acceptable in place of vaccinations.

Rule	Requirements
