## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days before the minimum interval or age are not considered valid and must be repeated as age-appropriate.

## Hepatitis B

Rule	Requirements
<b>1 dose 0-1 months</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is between 0 (zero) and 1 month old, and</li> <li>• the student receives 1 dose of the Hepatitis B vaccine.</li> </ul>

Rule	Requirements
<b>2 doses 2-3 months</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is between 2 and 3 months old,</li> <li>the student receives 2 doses of the Hepatitis B vaccine, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 3 doses of the Hepatitis B vaccine,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the last dose and the second valid dose is greater than 56 days with a 4 day tolerance,</li> <li>the difference between the last dose and the first valid dose is greater than 112 days with a 4 day tolerance, and</li> <li>the difference between the last dose and the student's birthdate is greater than 168 days with a 4 day tolerance.</li> </ul>
<b>2 doses</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the Hepatitis B vaccine, and</li> <li>the difference between the last dose and the effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Hepatitis B vaccine, and</li> <li>the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>Default</b> <i>Non-compliant</i>	N/A

<b>2 doses</b> <b>7+</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months old,</li> <li>the student receives 2 doses of the DT, DTaP, Td booster, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 1 day tolerance.</li> </ul>

## Tdap

Rule	Requirements
<b>Under 13</b> <i>No Requirements</i>	Students age 155 months old and younger are not required to receive any doses of the Tdap vaccine.

Rule	Requirements
<b>Td in the past 10 Years</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Td booster or Tdap vaccine,</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 84 months with a 4 day tolerance, and</li> <li>the difference between the last dose and the effective date is less than or equal to 119 months with a 4 day tolerance.</li> </ul>
<b>1 Dose Tdap</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Tdap or DTaP/DTP vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 84 months with a 4 day tolerance.</li> </ul>
<b>Default</b> <i>Non-compliant</i>	N/A

## Hib

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is no older than 58 months old, and</li> <li>the student receives 1 dose of the Hib vaccine.</li> </ul>
<b>Default</b> <i>Non-compliant</i>	The student is considered non-compliant if they are no older than 58 months old, and have not received any doses of the Hib vaccine.
<b>Default</b> <i>No Requirement</i>	N/A

## MMR

Rule	Requirements
<b>1 dose MMR</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is no older than 83 months old,</li> <li>the student receives 1 dose of the MMR or MMRV vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>

<b>1 dose M,M,R Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is no older than 83 months old,</li> <li>• the student receives 1 dose of the Measles vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives 1 dose of the Mumps vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives 1 dose of the Rubella vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul> </li> </ul>

<b>2 M,M,R Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives 2 doses of the Measles vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives 2 doses of the Mumps vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives 2 doses of the Rubella vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul> </li> </ul>

<b>1 dose under 7 years</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is no older than 83 months,</li> <li>the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>
<b>1 dose before 6/2007</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine,</li> <li>the last dose date was received on or before 5/30/2007, and</li> <li>the difference between the last dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>2 doses</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the seconds dose and previous is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>1 dose &gt; 13 year old</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 156 months old,</li> <li>the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose &lt; 13 year old</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is no older than 155 months old,</li> <li>the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>the difference between the last dose and the effective date is less than 2 months with a 0 (zero) day tolerance.</li> </ul>
<b>Default</b> <i>Non-compliant</i>	N/A

## Polio

Rule	Requirements
<b>0-1 months</b> <b>No Requirement</b>	Students age 0-1 months old are not required to receive any doses of the Polio vaccine.
<b>Age 18+</b> <b>No Requirement</b>	Students age 216 months (18 years) old and older are not required to receive any doses of the Polio vaccine.
<b>1 dose Age 2-3 Months</b> <b>Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in at least 2 months, but no older than 3 months old,</li> <li>the student receives 1 dose of the IPV, OPV, or IPV/OPV Polio vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<b>2 doses Age 4-5 Months</b> <b>Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in at least 4 months, but no older than 5 months old,</li> <li>the student receives 2 doses of the IPV, OPV, or IPV/OPV Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the first and second dose is greater than 28 days with a 4 day tolerance.</li> </ul>

<b>4 doses before Feb 2018</b> <b><i>Compliant</i></b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the last dose is received before 01/31/2018,</li> <li>• the student receives 4 doses of the IPV, OPV, or IPV/OPV Polio vaccine,</li> <li>• the difference between the third dose and the student's birthdate is less than 48 months with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>3 doses before Feb 2018</b> <b><i>Compliant</i></b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the last dose is received before 01/31/2018,</li> <li>• the student receives 3 doses of the IPV, OPV, or IPV/OPV Polio vaccine, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>4 doses before Feb 2018</b> <b><i>Compliant</i></b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the last dose is received before 01/31/2018,</li> <li>• the student receives 4 doses of the IPV, OPV, or IPV/OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 Day tolerance.</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the last and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is less than 48 months with a 4 day tolerance.</li> </ul>

<p><b>3 doses Over Age 4 Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is 48 months of age or older,</li> <li>• the student receives 3 doses of the IPV, OPV, or IPV/OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<p><b>1 dose In Progress</b></p>	<p>The student is considered in progress when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives at least one dose of the IPV, OPV, or IPV/OPV Polio vaccine, and</li> <li>• the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses</b> <b><i>In Progress</i></b>	<p>The student is considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives at least two doses of the IPV, OPV, or IPV/OPV Polio vaccine, and</li> <li>the difference between the dose and the effective date is less than 6 months with a 0 (zero) day tolerance.</li> </ul>

## Pneumococcal

Rule	Requirement
<b>Age 0-1 months</b> <b><i>No Requirement</i></b>	<p>Students younger than 1 month old are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.</p>
<b>Ages 5 and older</b> <b><i>No Requirement</i></b>	<p>Students 60 months (5 years) of age and older are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.</p>
<b>1 dose required</b> <b>ages 2-3 months</b> <b><i>Compliant</i></b>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is between 2 and 3 months of age,</li> <li>the student receives 1 dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>the difference between the dose and the student's birthdate if greater than 42 days with a 4 day tolerance.</li> </ul>
<b>2 doses required</b> <b>age 4-5 months</b> <b><i>Compliant</i></b>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is between 4 and 5 months of age,</li> <li>the student receives 2 doses of the Pneumococcal PCV or PPV vaccine,</li> <li>the difference between the first dose and the student's birthdate if greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>

<p><b>3 doses required 6-11 months Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is between 6 and 11 months of age,</li> <li>• the student receives 3 doses of the Pneumococcal PCV or PPV vaccine,</li> <li>• the difference between the first dose and the student's birthdate if greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the second dose and the student's birthdate is less than 6 months with a 4 day tolerance.</li> </ul>
<p><b>4 doses 12 months Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 12 months of age,</li> <li>• the student receives 4 doses of the Pneumococcal PCV or PPV vaccine,</li> <li>• the difference between the first dose and the student's birthdate if greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the previous is greater than 56 days with a 4 day tolerance.</li> </ul>

<p><b>3 doses 12 months, 7-11 shot</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 12 months of age,</li> <li>• the student receives 3 doses of the Pneumococcal PCV or PPV vaccine,</li> <li>• the difference between the first dose and the student's birthdate if greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 56 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the student's birthdate is greater than 7 months with a 4 day tolerance,</li> <li>• the difference between the second dose and the student's birthdate is less than 11 months with a 4 day tolerance, and</li> <li>• the difference between the third dose and the previous is greater than 12 months with a 4 day tolerance.</li> </ul>

Rule	Requirement
<b>1 dose over 24 months</b> <b><i>Compliant</i></b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 24 months of age,</li> <li>the student receives 1 dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than 24 months with a 4 day tolerance.</li> </ul>
<b>1 Dose IP</b> <b><i>In Progress</i></b>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Rotavirus

Rule	Requirement
<b>Under 2 months</b> <b><i>No Requirement</i></b>	Students younger than 2 months old are not required to receive any doses of the Rotavirus (Rota) vaccine.
<b>Over 8 months</b> <b><i>No Requirement</i></b>	Students 8 months of age or older are not required to receive any doses of the Rotavirus (Rota) vaccine.
<b>1 dose</b> <b><i>Compliant</i></b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Rotavirus (Rota) vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<b>2 dose</b> <b><i>Compliant</i></b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the Rotavirus (Rota) vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second dose and the student's birthdate is greater than 28 days with a 4 day tolerance.</li> </ul>

Rule	Requirement
<b>1 dose IP</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"><li>• the student receives 1 dose of the Rotavirus (Rota) vaccine, and</li><li>• the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li></ul>
