The following information describes vaccine compliance rules as defined by the Wisconsin Department of Health Services.

General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- Doses administered 5 days earlier than the minimum interval or age are not counted as valid doses and must be repeated as age-appropriate.
- In Process and Behind Schedule rules are considered Non-Compliant.

In Process Rules

The following rules are included for all vaccines (These rules do not apply to students who do not have a requirement for Tdap):

No doses first year <i>In Process</i>	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have not received any doses of the vaccines listed below in the first year of the student's enrollment are considered in process.

1 dose first year <i>In Process</i>	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have received one dose of the vaccines listed below in the first year of the student's enrollment are considered in process.
2 doses first year <i>In Process</i> <div style="background-color: #fff9c4; padding: 5px; margin-top: 10px;"> Not needed for MMR </div>	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have received two doses of the vaccines listed below in the first year of the student's enrollment are considered in process.
2 doses second year <i>In Process</i>	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have received two doses of the vaccines listed below in the second year of the student's enrollment are considered in process.
KG Default <i>In Process</i>	Students in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten and have received 1 dose of the vaccines listed below are considered in process.

DTaP

Rule	Conditions
4 doses PreK <i>Compliant</i>	Students are considered compliant when the following conditions have been met: Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, and the student receives four doses of the DT, or DTAP/DTP vaccines.
3 or more doses <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, the student receives three or more doses of the DT, DTAP/DTP, Td, or Tdap vaccines with one dose received after age 4, and the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.

Polio

Rule	Condition
3 doses PreK <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, and the student receives three doses of the IPV, OPV, or IPV/OPV vaccines.
3 doses K-12 <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student receives three doses of the IPV, OPV, or IPV/OPV vaccines, and the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.
4 doses K-12 <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student receives four doses of the IPV, OPV, or IPV/OPV vaccines.

Measles Mumps Rubella MMR

Rule	Condition
1 dose PreK <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, the student receives one dose of the MMR or MMRV vaccines, and the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.
1M, 1M, 1R PreK <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, the student receives one dose of the Measles vaccine, <ul style="list-style-type: none"> the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR the student receives one dose of the Mumps, <ul style="list-style-type: none"> the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR the student receives one dose of the Rubella, <ul style="list-style-type: none"> the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.
2 doses K-12 <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student receives two doses of the MMR or MMRV vaccines, and the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.

Rule	Condition
1MMR, 1M, 1M, 1R K-12 <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> • the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, • the student receives one dose of the MMR or MMRV vaccine, <ul style="list-style-type: none"> ◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, • the student receives one dose of the Measles vaccine, <ul style="list-style-type: none"> ◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR • the student receives one dose of the Mumps, <ul style="list-style-type: none"> ◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR • the student receives one dose of the Rubella, <ul style="list-style-type: none"> ◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.
2M, 2M, 2R, K-12 <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> • the student receives two doses of the Measles vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR • the student receives two doses of the Mumps, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR • the student receives two dose of the Rubella, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.

Hepatitis B

Rule	Condition
3 doses <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> • the student receives three doses of the Hepatitis B, Hepatitis B 2 Dose, or Hepatitis B 3 dose vaccines.
2 doses <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> • the student receives two doses of the Hepatitis B 2 Dose vaccine.

Varicella

Rule	Condition
2 doses <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and the student receives two doses of the MMRV or Varicella vaccines.

Tdap

Rule	Condition
PK-6th Grade <i>No Requirements</i>	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06 are not required to receive any doses of the Tdap vaccine.
1 Tdap grades 07-12 <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 10, 11, 12, and the student receives one dose of the Tdap vaccine.
1 dose within 5 yrs of 7th grade <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade 07, the student receives one dose of the TD, DT, or DTaP vaccine, and the difference between the last dose the start of 7th grade for the student is less than or equal to 59 months with a 1 day tolerance.
1 dose with 6 yrs of 8th grade <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade 08, the student receives one dose of the TD, DT, or DTaP vaccine, and the difference between the last dose the start of 8th grade for the student is less than or equal to 71 months with a 1 day tolerance.

Rule	Condition
<p>1 dose with 7 yrs of 9th grade <i>Compliant</i></p>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> • the student is in state grade 09, • the student receives one dose of the TD, DT, or DTaP vaccine, and • the difference between the last dose the start of 9th grade for the student is less than or equal to 83 months with a 1 day tolerance.
<p>1 dose with 8 yrs of 10th grade <i>Compliant</i></p>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> • the student is in state grade 10, • the student receives one dose of the TD, DT, or DTaP vaccine, and • the difference between the last dose the start of 10th grade for the student is less than or equal to 95 months with a 1 day tolerance.
<p>1 dose with 9 yrs of 11th grade <i>Compliant</i></p>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> • the student is in state grade 11, • the student receives one dose of the TD, DT, or DTaP vaccine, and • the difference between the last dose the start of 11th grade for the student is less than or equal to 107 months with a 1 day tolerance.
<p>1 dose with 10 yrs of 12th grade <i>Compliant</i></p>	<p>Students are considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> • the student is in state grade 12, • the student receives one dose of the TD, DT, or DTaP vaccine, and • the difference between the last dose the start of 12th grade for the student is less than or equal to 119 months with a 1 day tolerance.
<p>Default <i>Behind Schedule</i></p>	<p>Students are considered behind schedule when they are in state grade(s): 06, 07, 08, 09, 10, 11, 12, and have not received any doses of the Tdap vaccine.</p>

Meningococcal

Rule	Requirements
<p>PK-6th and 8th-11th (24-25 School Year) <i>No Requirement</i> <i>Active End Date:</i> <i>06/30/2025</i></p>	<p>Students in state grade(s) K3, K4, PK, KG, 01, 02, 03, 04, 05, 06, 08, 09, 10, or 11 are not required to receive any doses of the Meningococcal vaccine.</p>
<p>PK-6th and 9th-11th (25-26 School Year) <i>No Requirement</i> <i>Active Start Date:</i> <i>07/01/2025</i> <i>Active End Date:</i> <i>06/30/2026</i></p>	<p>Students in state grade(s) K3, K4, PK, KG, 01, 02, 03, 04, 05, 06, 09, 10, or 11 are not required to receive any doses of the Meningococcal vaccine.</p>
<p>PK-6th and 10th-11th (26-27 School Year) <i>No Requirement</i> <i>Active Start Date:</i> <i>07/01/2026</i> <i>Active End Date:</i> <i>06/30/2027</i></p>	<p>Students in state grade(s) K3, K4, PK, KG, 01, 02, 03, 04, 05, 06, 10, or 11 are not required to receive any doses of the Meningococcal vaccine.</p>
<p>PK-6th and 11th (27-28 School Year) <i>No Requirement</i> <i>Active Start Date:</i> <i>07/01/2027</i> <i>Active End Date:</i> <i>06/30/2028</i></p>	<p>Students in state grade(s) K3, K4, PK, KG, 01, 02, 03, 04, 05, 06, 11 are not required to receive any doses of the Meningococcal vaccine.</p>
<p>PK-6th (28-29 School Year) <i>No Requirement</i> <i>Active Start Date:</i> <i>07/01/2028</i></p>	<p>Students in state grade(s) K3, K4, PK, KG, 01, 02, 03, 04, 05, or 06 are not required to receive any doses of the Meningococcal vaccine.</p>
<p>1 dose <i>Compliant</i></p>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> • The student is in state grade 07, 08, 09, 10, 11, or 12. • The student receives one dose of the MCV4 or MenACWY vaccine.
<p>12th grade 2 doses <i>Compliant</i></p>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> • They are in state grade(s) 12. • They receive two doses of the MenACWY or MCV4 Meningococcal vaccine.

Rule	Requirements
12th grade 1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • They are in state grade(s) 12. • They receive one dose of the MenACWY or MCV4 Meningococcal vaccine. • The difference between the last dose and the student's birthdate is greater than or equal to 192 months (16 years) with a 4-day tolerance.
12th grade - 1 dose <i>In Process</i> <i>Active End Date:</i> <i>06/30/2025</i>	Students are in process when they are between 132 and 191 months old, in state grade 12, and receive one dose of the MenACWY or MCV4 Meningococcal vaccine.
Default <i>Behind Schedule</i>	Students who do not meet the above requirements are considered Behind Schedule.
