## Immunization Rules

The following tables describe Maine immunization requirements per vaccine.

### DTap

Rule	Requirement
<b>0-14 months</b> <i>No Requirements</i>	Students 14 months old or younger are not required to receive any doses of the Diphtheria-tetanus-pertussis (DTaP, DTP) vaccine.

Rule	Requirement
<p><b>15-35 months</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 15 months old and no older than 35 months,</li> <li>the student is in state grade: PR: 4 Year Old Program or PK: Pre Kindergarten, and</li> <li>the student receives three doses of the Diptheria-tetanus-pertussis (DTaP, DTP), DT, Td, of Tdap vaccine.</li> </ul>
<p><b>36 months and older</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 36 months (3 years) old,</li> <li>the student is in state grade: PR: 4 Year Old Program or PK: Pre Kindergarten,</li> <li>the student receives four doses of the Diptheria-tetanus-pertussis (DTaP, DTP), DT, Td, of Tdap vaccine, and</li> <li>the difference between the fourth and previous dose is greater than or equal to 6 months with a 4 day tolerance.</li> </ul>
<p><b>5 doses</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>the student receives five doses of the Diptheria-tetanus-pertussis (DTaP, DTP), DT, Td, of Tdap vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than or equal to 28 days with a 4 day tolerance, and</li> <li>the difference between the fifth and previous dose is greater than or equal to 6 months with a 4 day tolerance.</li> </ul>

Rule	Requirement
<p><b>4 doses</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives four doses of the Diptheria-tetanus-pertussis (DTaP, DTP), DT, Td, of Tdap vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<p><b>3 doses</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 84 months (7 years) old,</li> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives three doses of the Diptheria-tetanus-pertussis (DTaP, DTP), DT, Td, of Tdap vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 48 months (4 year) with a 4 day tolerance.</li> </ul>

Rule	Requirement
<b>3 doses catch up</b> <i>Compliant</i>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>the student receives three doses of the Diptheria-tetanus-pertussis (DTaP, DTP), DT, Td, of Tdap vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous is greater than or equal to 6 months with a 4 day tolerance,</li> <li>the student receives one dose of the Tdap vaccine AND <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than or equal to 87 months (7 years) with a 4 day tolerance.</li> </ul> </li> </ul>

## Polio

Rule	Requirements
<b>0-5 months</b> <b>No Requirement</b>	<p>Students 5 months old or younger are not required to receive any doses of the Polio (IPV, OPV) vaccine.</p>
<b>6-35 months</b> <b>Compliant</b>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 6 months old and no older than 35 months old,</li> <li>the student is in state grade: PR: 4 Year Old Program or PK: Pre Kindergarten, and</li> <li>the student receives two doses of the OPV, IPV, or combined IPV, OPV Polio vaccine.</li> </ul>
<b>36 months and older</b> <b>Compliant</b>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 36 months (3 years) old,</li> <li>the student is in state grade: PR: 4 Year Old Program or PK: Pre Kindergarten, and</li> <li>the student receives three doses of the OPV, IPV, or combined IPV, OPV Polio vaccine.</li> </ul>

Rule	Requirements
<p><b>4 doses Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives four doses of the OPV, IPV, or combined IPV, OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 0 (zero) day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 0 (zero) day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 0 (zero) day tolerance, and</li> <li>• the difference between the fourth dose and the previous is greater than 28 days with a 0 (zero) day tolerance.</li> </ul>
<p><b>3 doses IPV Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives three doses of the IPV or combined IPV, OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 0 (zero) day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 0 (zero) day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 0 (zero) day tolerance, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 48 months with a 0 (zero) day tolerance.</li> </ul>
<p><b>3 doses OPV Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives three doses of the OPV or combined IPV, OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 0 (zero) day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 0 (zero) day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 0 (zero) day tolerance, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 48 months with a 0 (zero) day tolerance.</li> </ul>

# MMR

## Measles-Mumps-Rubella

Rule	Requirements
<b>0-14 months</b> <b>No</b> <b>Requirements</b>	Students 14 months old or younger are not required to receive any doses of the Measles-Mumps Rubella (MMR) vaccine.
<b>1 dose MMR</b> <b>Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is in state grade: PR: 4 Year Old Program or PK: Pre Kindergarten, and</li> <li>• the student receives one dose of the Measles-Mumps Rubella (MMR) or Measles-Mumps-Rubella-Varicella (MMRV) vaccine.</li> </ul>
<b>1M 1M 1R</b> <b>Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is in state grade: PR: 4 Year Old Program or PK: Pre Kindergarten,</li> <li>• the student receives one dose of the Measles vaccine,</li> <li>• the student receives one dose of the Mumps, vaccine, and</li> <li>• the student receives one dose of the Rubella vaccine.</li> </ul>
<b>2 doses MMR</b> <b>Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives two doses of the Measles-Mumps Rubella (MMR) or Measles-Mumps-Rubella-Varicella (MMRV) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>• the difference between the second dose and previous is greater than 28 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>1MMR 1M 1M 1R</b> <b>Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives two doses of the Measles, Measles-Mumps Rubella (MMR), or Measles-Mumps-Rubella-Varicella (MMRV) vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives two doses of the Mumps, Measles-Mumps Rubella (MMR), or Measles-Mumps-Rubella-Varicella (MMRV) vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives two doses of the Rubella, Measles-Mumps Rubella (MMR), or Measles-Mumps-Rubella-Varicella (MMRV) vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul> </li> </ul>
<p><b>2M 2M 2R</b> <b>Compliant</b></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12,</li> <li>• the student receives two doses of the Measles vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives two doses of the Mumps vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives two doses of the Rubella vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul> </li> </ul>

# Hep B

## Hepatitis B

Rule	Requirements
<b>0-14 months</b> <i>No Requirement</i>	Students 14 months old or younger are not required to receive any doses of the Hepatitis B vaccine.
<b>36 months and older</b> <i>No Requirement</i>	Students 36 months (3 years) and older are not required to receive any doses of the Hepatitis B vaccine.
<b>15-35 months</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 15 months old and no older than 35 months old, and</li> <li>the student receives three doses of the Hepatitis B vaccine.</li> </ul>

## Hib

### Haemophilus influenza

Rule	Requirements
<b>0-14 months</b> <i>No Requirements</i>	Students 14 months old or younger are not required to receive any doses of the Haemophilus influenza (Hib) vaccine.
<b>18 months and older</b> <i>No Requirements</i>	Students 18 months old or older are not required to receive any doses of the Haemophilus influenza (Hib) vaccine.
<b>15-17 months</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 15 months old and no older than 17 months old, and</li> <li>the student receives three doses of Haemophilus influenza (Hib) vaccine.</li> </ul>

## Pneumococcal



Rule	Requirements
<b>0-14 months</b> <i>No Requirements</i>	Students 14 months old or younger are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.
<b>18 months and older</b> <i>No Requirements</i>	Students 18 months old or older are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.
<b>15-17 months</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 15 months old and no older than 17 months old, and</li> <li>the student receives four doses of Pneumococcal PCV or PPV vaccine.</li> </ul>

## Varicella

Rule	Requirements
<b>0-11 months</b> <i>No Requirements</i>	Students 11 months old or younger are not required to receive any doses of the Varicella vaccine.
<b>1 dose</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the Varicella vaccine, and</li> <li>the difference between the first dose and the student's birthdate is less than 12 months with a 4 day tolerance.</li> </ul>
<b>2 doses K-12</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Varicella vaccine,</li> <li>the student is in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the difference between the first dose and the student's birthdate is less than 12 months with a 4 day tolerance, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>Default K-12</b> <i>Non-Compliant</i>	Students in state grade(s): KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, who have not received any doses of the Varicella vaccine are considered non-compliant.

# Tdap

Tetanus, Diphtheria and Acellular Pertussis [Tdap]

Rule	Requirement
<b>1 dose</b> <b>Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09,10, 11, 12 and</li> <li>the student receives one dose of the Tetanus, Diptheria and Acellular Pertussis (Tdap) vaccine.</li> </ul>
<b>No doses</b> <b>Non-Compliant</b>	The student is considered non-compliant when the student is in state grade: 07, 08, 09, 10, 11, 12, and the student does not receive any doses of the Tetanus, Diptheria and Acellular Pertussis (Tdap) vaccine.

# Meningococcal

Rule	Requirement
<b>1 dose</b> <b>Compliant</b> <i>Active Start</i> <i>Date: 8/1/18</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12 and</li> <li>the student receives one dose of Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
<b>2 dose</b> <b>Compliant</b> <i>Active Start</i> <i>Date: 8/1/18</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 12,</li> <li>the student receives two doses of Meningococcal (MCV4 or MenACWY) vaccine,</li> <li>the difference between the last dose and the student's birthdate is greater than 192 months with a 4 day tolerance, and</li> <li>the difference between the last dose and the previous is greater than 56 days with a 4 day tolerance.</li> </ul>
<b>1 dose 16+</b> <b>Compliant</b> <i>Active Start</i> <i>Date: 8/1/18</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 12,</li> <li>the student receives one dose of Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>the difference between the first dose and the student's birth date is greater than 192 months with a 4 day tolerance.</li> </ul>

Rule	Requirement
<p><b>1 dose</b> <b><i>In Progress</i></b> <i>Active Start</i> <i>Date: 8/1/18</i></p>	<p>The student is considered in progress when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: 12,</li> <li>• the student receives one dose of Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 56 days with a 4 day tolerance.</li> </ul>
<p><b>Default 7, 8, 12</b> <b><i>Non-Compliant</i></b> <i>Active Start</i> <i>Date: 8/1/18</i></p>	<p>The student is considered non-compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in State Grades: 07, 08, 09, 10, 11, 12 and</li> <li>• the student does not receive any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>
