

# Behavior Admin Setup (Hawaii)



The Behavior Admin tool is used to setup behavior events/incidents, resolutions, and responses. Behavior Admin fields that are specific to the state of Hawaii are described below. For all other inquiries, please visit the [Behavior Admin](#) article.

Individual schools should NOT setup their own Event or Resolution Types. These items should only be setup at the state level.

Before setting up Event Types, Resolution Types, or Preferences, be SURE the campus toolbar does NOT have a school or calendar selected; this makes the behavior event type available for all schools within the district.



## Event Types

Behavior Event Types are created for the entire district.

Tool Rights should be set to limit who is permitted to setup Event Types.

Before setting up Event Types, be sure the campus tool bar does NOT have a school or calendar selected. Event types are meant to be available to all schools within the district.

## Classification

Indicates the incident type that took place.

Code	Description	Definition
01	None	Used for incidents that do not involve drugs, harassment, or weapons (i.e. fighting, breaking class rules, etc)
02	Drug	Used for incidents that involve drugs or alcohol. Users are able to specify the drug(s) involved when creating the Behavior Incident <div style="background-color: #ffffcc; padding: 10px; margin-top: 10px;">             This Event Type requires users to enter the following information to a Behavior Incident: CRAFT Screening Conducted Date, CRAFT Screening Results, and Drug Type.           </div>
03	Harassment	Used for incidents that involve harassment. In Hawaii, Harassment is often recorded through Protected Class, Harassment Incidents are rarely created <div style="background-color: #ffffcc; padding: 10px; margin-top: 10px;">             This Event Type requires users to enter the specific Harassment Type to a Behavior Incident.           </div>
04	Weapon	Used for incidents that involve weapons. Users are able to specify the weapon(s) involved when creating the Behavior Incident <div style="background-color: #ffffcc; padding: 10px; margin-top: 10px;">             This Event Type requires users to enter the specific Weapon Type to a Behavior Incident.           </div>

## Resolution Type


Tool Search: Resolution Types

The Resolution Types editor allows users to create and manage resolution codes assigned to student behavior events. Behavior Resolutions are used to describe action taken as a result of a behavior event, such as detention or an award for good behavior. Codes can be created to reflect positive and negative behavior events.

Tool Rights should be set to limit who is permitted to setup Event Types.

Behavior Resolutions are created for the entire district. When setting up Behavior Resolutions, the Campus Toolbar should NOT have a school or calendar selected; Resolution Types are meant to be available to all schools within the district. When a school is selected, behavior codes are applied to that school only. Individual schools should NOT setup their own Resolution Types.

## State Resolution Code (Mapping)

State Resolution Codes indicate the type of disciplinary action taken for a student. These are the official state codes to which all district-defined behavior resolutions should be mapped. Behavior resolutions that are not mapped to a state event code do NOT report.

Type	Code	Description	Definition
State Code	AEA	Alternate Educational Activities	An educational program, in a non-school setting, other than home schooling, that addresses the standards identified in the Hawaii Content and Performance Standards. AEA resolutions are offered to students who are being suspended as a result of their role in a Behavior Incident.
State Code	A	Arrest	Law Enforcement makes an arrest.
Sub-Type	S	Suspension	<p>Student is suspended from school.</p> <p>Suspension resolutions must <i>always</i> include the following criteria:</p> <ul style="list-style-type: none"> <li>• Mapped to State Resolution Code of AEA: Alternative Educational Activities</li> <li>• Intervention checkbox IS selected</li> </ul>
Other Options	I	Intervention	Marking this checkbox indicates Interventions can be offered to students involved in behavior incidents as a proactive action plan to address behavior(s) that are impeding learning of the student or others. Interventions typically include positive behavioral interventions, strategies, and supports. Leaving this checkbox unmarked means Interventions will NOT be available to incidents tied to the Resolution.
Other Options	N/A	Calculate End Date/Duration	When marked, the duration of a behavior resolutions is automatically calculated when that resolution type is assigned to a student and a length of time is entered into the field.
Other Options	N/A	Allow attendance modification	When marked, student attendance data will be updated upon completion of the behavior resolution. Marking this also displays an Attendance Code field on the Resolution editor where users can assign the appropriate behavior-related attendance code to the student. This should be marked on those resolutions where a student would be absent because of the resolution: out-of-school suspensions, expulsions, etc.

## Sub-Type


The Sub-Type selection makes the resolution available in different behavior processing tools. In Hawaii, the Suspension Sub-Type requires specific setup. Please see below for further instruction.

If setting up a resolution Sub-Type of Suspension, the following setup is REQUIRED:

- Ensure the **Calculate End Date/Duration** checkbox **IS** checked.
- *State Resolution Code (Mapping)* **MUST** be mapped to: **Alternate Educational Activities**.
- The Resolution **Sub-Type** **MUST** be: **Suspension**.

## Suspension Days Threshold

The Suspension Days Threshold field is a campus-calculated value based on the total number of instructional days in the calendar and divides it by two. The result of this calculation determines the instructional day on which the instructional calendar is midpoint in the year. For example, for a school year that has 180 instructional days, the halfway point is 90 days. The value in this field allows the Behavior module to track Total Suspension Days for students in the instructional calendar year.
