

# Nebraska Ed-Fi Data v3.1 - Discipline Actions

This event entity represents actions taken by an education organization after a disruptive event that is recorded as a discipline incident.

## Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	Reports when a Behavior Resolution is added to an incident that is marked as Complete and saved. <ul style="list-style-type: none"> <li>Only report behavior resolutions that have state code with an Ed-Fi Code value and are aligned to a reported Student Discipline Incident Association record.</li> <li>Do not send if the student is in a School marked as Exclude.</li> <li>Do not send if the student's enrollment is marked as No Show or State Exclude.</li> <li>Do not send if the student is in a calendar marked as Exclude.</li> </ul>
Delete/Post	When data that is part of the Natural Key is changed. <ul style="list-style-type: none"> <li>If the resolution date is changed do a delete and post.</li> </ul>
Delete/Post	When the Incident's status is changed. <ul style="list-style-type: none"> <li>Delete when the status is changed from Completed to In Progress.</li> <li>Post when the status is changed from In Progress to Completed.</li> </ul>
Put	When a state mapped discipline is added or removed and there are other state mapped resolutions on the incident.
Delete	When a resolution is deleted.
Delete	When all resolutions mapped to a State Resolution code with an Ed-Fi Code are removed from the incident.
Delete	When all Behavior Events that are mapped to a State Code with an Ed-Fi value are removed from the Incident.
Delete	If the state mapping on the event is changed to NULL or Not State Reported and no other state mapped event exists on the incident.
Delete	When all non-excluded enrollments in the school and year are deleted.

## School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.

## Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	Natural Key changes: <ul style="list-style-type: none"> <li>If an Ed-Fi ID changes, this will happen with the cascading deletes from the Ed-Fi ID Change trigger.</li> <li>If the Discipline Date changes.</li> </ul>

## Scope Year Logic

Logic
Discipline records will only send to the school year they are aligned to.
Data will only send for the years that have valid configuration.
