

# Nebraska Ed-Fi Data v3.1 - Student School Food Service Program Associations

This association represents the school food services program(s), such as the Free or Reduced Lunch Program, that a student participates in or from which the Student receives services.

## Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	When the student has an Eligibility Type that is mapped to an Ed-Fi code. <ul style="list-style-type: none"> <li>Do not send a record if enrollment is in a calendar marked as Exclude.</li> <li>Do not send a record if enrollment is in a school marked as Exclude.</li> <li>Do not send a record if enrollment is marked as No Show.</li> </ul>
Delete/Post	When any field part of the natural key is changed. <ul style="list-style-type: none"> <li>Student Ed-Fi ID</li> <li>Start Date</li> </ul>
Put	When any field not part of the natural key is changed. <ul style="list-style-type: none"> <li>End Date</li> <li>Eligibility</li> </ul>
Delete	All enrollments are deleted for a student.
Delete	If the student's enrollment is marked as No Show.
Delete	If the Eligibility record is deleted.
Delete	If the start /end dates on the Eligibility record are updated so the record no longer overlaps the configured year.

## School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.

## Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	Natural Key changes: <ul style="list-style-type: none"> <li>• LEA Reference - District Numbers cannot change after data has been sent. If a district number changes, we would expect an Ed-Fi error and this change would not be supported.</li> <li>• If an Ed-Fi ID changes, a delete/post will occur with the cascading deletes from the Ed-Fi ID Change triggers.</li> <li>• If the Program Name or Program Type Descriptor mapping changes and a resync is completed.</li> <li>• If the Eligibility record Start Date changes the resource will delete/repost.</li> </ul>
Delete	Cascading Deletes: N/A - no dependent resources.

## Scope Year Logic

This table describes scope year logic of this object.

Logic
The record will send to the configured year that the School Year from the Eligibility record aligns to if the student has an enrollment in that year.
Data will only send for the years that have valid configuration.
