Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	When the student has an Eligibility Type that is mapped to an Ed-Fi code. <ul style="list-style-type: none"> Do not send a record if enrollment is in a calendar marked as Exclude. Do not send a record if enrollment is in a school marked as Exclude. Do not send a record if enrollment is marked as No Show.
Delete/Post	When any field part of the natural key is changed. <ul style="list-style-type: none"> Student Ed-Fi ID Start Date
Put	When any field not part of the natural key is changed. <ul style="list-style-type: none"> End Date Eligibility
Delete	All enrollments are deleted for a student.
Delete	If the student's enrollment is marked as No Show.
Delete	If the Eligibility record is deleted.
Delete	If the start /end dates on the Eligibility record are updated so the record no longer overlaps the configured year.

School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.
