An error was occurring due to the descriptor droplist for the Student Characteristic Descriptors - Economic Disadvantaged in the Student Education Organization Associations resource being hidden. This issue has been resolved.

## Localization - Colorado

Colorado - VE-135 File (SIS-138241)

The following modifications have been made to the VE-135 File:

- The Phone Number now reports the 7-digit number of the student's most recent primary phone number without hyphens or parenthesis.
- Logic for Concentrator has been modified to report a value of 1 when the student has a Vocational Education record that was active at any time during the school year AND contains a Status of CON: Concentrator. All others report a value of 0.
- When a student has a Vocational Education record that was active at any time during the school year AND contains a Status of COM: Completer, a value of 1 reports. All others report 0.
- When a student has a Vocational Education record that was active at any time during the school year AND contains a Status of PAR: Participant, a value of 1 reports. All others report 0.
- When a student has a status of COM, they report both as COM and CON.
- When a student has multiple Vocational Education records with matching VE Program ID and CIP Code, all applicable statuses report in one row.
- When a student has multiple Vocational Education records with non-matching VE Program ID and CIP Code, all unique instances report in separate rows.

## Localization - Texas

Texas - Submission 3 PEIMS updates (SIS-137739)

Logic has been updated to the TX-SchoolDayOperationalMinutes field found in the Education Organization Calendar Interchange extract. This field will only report for calendars where the Instructional Program Type is 01, 02 or 14.

Logic has been updated to the TX-DyslexiaRiskCode field found in the Student Interchange extract. If a student's grade level is KG or 01 and the student has an active Dyslexia record with a Dyslexia Risk Code value, the value will report. Dyslexia Risk Codes without a value will report as 00 and all others will not report.

An error was produced when attempting to generate the Master Schedule Interchange where a staff ad hoc filter was selected for ECDS PK, ECDS KG and Class Roster reports. This has been corrected.
