If a student's photo opt in status changes from Opt In to Opt Out, the photo will be removed from the State Edition. If a student's photo opt in status changes from Opt In to Unknown, the photo will continue to display in State Edition.

The Student Demographics Import and Extract have been updated to include a new Photo Opt In element. This element will report/import values for the Missing Student Photo Opt In field.

- A value of Opt In in the Import would always update the field to display Opt In
- A value of Opt Out in the Import would always update the field to Opt Out
- A value of Unknown in the Import would only update the field if it were previously blank.
- A value of blank in the import would never update the current value of the field.
