# **Object Triggering Logic**

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<ul> <li>When a new enrollment with a distinct start date and State Enrollment Type of Primary is created.</li> <li>Do not send a record if enrollment is in a grade level marked Exclude.</li> <li>Do not send a record if enrollment is in a school marked Summer School.</li> <li>Do not send a record if enrollment has State Enrollment Type of Coursework Only, PPP, or Programs Only.</li> <li>If the student has more than one enrollment record, only one record will report.</li> <li>Do not send a record if enrollment is in a calendar marked as Exclude.</li> <li>Do not send a student record for an enrollment that is marked as State Exclude, No Show, or WISE Exclude.</li> <li>If the student has a FRAM record that overlaps the enrollment, the record will post using that records data.</li> <li>If the student does not have a FRAM record that overlaps the enrollment, the record will post using the enrollment Start and End Dates.</li> <li>If the student has more than 1 State Enrollment Type = Primary, the student will get a record for each enrollment.</li> <li>If Ed-Fi Configuration Profile = Choice + Opt in report a record for all eligible students if Choice = Yes or No on the student's enrollment.</li> <li>If Ed-Fi Configuration Profile = Choice AND Choice = No on the student's enrollment, do not report a record.</li> <li>When a resync is completed for all schools, if a student has multiple enrollments that meet the requirements, any existing FRAM records for each enrollment in the reported year must remain.</li> </ul>

#### School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.

The record will send to the configured year that the School Year from the Eligibility record aligns to if the student has an enrollment in that year.

Data will only send for the years that have valid configuration.
