Action	Trigger
Post	Post all Districts populated in the District table. <ul style="list-style-type: none"> A resync must be completed for all Districts to post but a UI change will trigger the reporting District to post.
Put	When fields not part of the natural key are changed: District Name, Phone or Physical Address is changed.
Delete	Records are never deleted once they are sent.

Resource Preferences & Toggle/Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Business Rule
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS and no new data will send..
Resync	If an Ed-Fi Code mapping is changed to a new code or made NULL, a resync must be performed for the data to be updated in the ODS.
