Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	Post all Districts populated in the District table. • A resync must be completed for all Districts to post but a UI change will trigger the reporting District to post.
Put	When fields not part of the natural key are changed: District Name, Phone or Physical Address is changed.
Delete	Records are never deleted once they are sent.

Resource Preferences & Toggle/Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Business Rule
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS and no new data will send
Resync	If an Ed-Fi Code mapping is changed to a new code or made NULL, a resync must be performed for the data to be updated in the ODS.

Action	Business Rule
Delete/Post	Natural Key change:
Delete	If the LEA ID changes all dependent resources will be deleted and only reposted if the new LEA ID has claim to the district to send data.

	Cascading Deletes: If the Ed-Fi District Number or State District Number changes, all dependent resources will be deleted.
