A new District Assignment checkbox called "Activity Staff" is now available. When this checkbox is marked, the staff member may be assigned as the primary or secondary owner responsible for an activity in the Activity Registration tool. This new option was also added as a "Role" for districts that use the Human Resources module.

A new option called "Receipt Comments" was added to Step 4 - Link to Portal in the Activity Builder

tool. This field allows you to enter comments or special instructions that you want on the customer's receipt.

The "Post to Course Section" toggle is now available on the Roster tool. When the toggle is turned on, you can associate the activity with a School, Calendar, Course and Section then you can push the applicable students to the roster in Campus once registration is closed.

## Blended Learning

### [Virtual Attendance Preferences \(SIS-138400\) \[Enhancement\]](#)

New Virtual Attendance Preferences are now available for tracking student participation in a virtual classroom setting.

For virtual students in a course section, users can:

- Use classroom attendance
- Turn off classroom attendance, so all attendance is processed through administrative tools.
- Choose to allow students and/or parents to check in for the day or for each course section.
- Choose a start and end time for daily or course check in or limit check in between the period start and end times.
- Allow the teacher to mark a student as participated for a number of previous days.
- Allow the teacher to override a student's participation check in.

Options for posting virtual attendance are also available. These options determine when the attendance entries are posted and what attendance code is used.
