## DTaP DTP

Diphtheria-tetanus-pertussis, combined [DTaP, DTP] (code: DTaP-DTP)

Rule	Requirements
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the DTaP, DTP vaccine.
<b>1 dose Age 2-5 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months old, but no older than 5 months old,</li> <li>the student receives one dose of the DTaP/DTP, DT, TD, or Tdap vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>2 doses Age 4-8 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 4 months old, but no older than 8 months old,</li> <li>the student receives two doses of the DTaP/DTP, DT, TD, or Tdap vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<p><b>3 doses Age 6-18 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 6 months old, but no older than 18 months old,</li> <li>the student receives three doses of the DTaP/DTP, DT, TD, or Tdap vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>the difference between the third and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<p><b>4 doses under 7</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is no older than 83 months,</li> <li>the student is in state grade: PK,</li> <li>the student receives four doses of the DTaP/DTP, DT, TD, or Tdap vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth and previous dose is greater than 4 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

Rule	Requirements

<p><b>5 doses</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives five doses of the DTaP/DTP, DT, TD, or Tdap vaccine,</li> <li>• the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than 4 months with a 4 day tolerance, and</li> <li>• the difference between the fifth and previous dose is greater than 6 months with a 4 day tolerance.</li> </ul>

<p><b>4 doses 7+</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 84 months (7 years) old,</li> <li>• the student receives four doses of the DTaP/DTP, DT, TD, or Tdap vaccine,</li> <li>• the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than 6 months with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>

<p><b>2 doses 7+</b> <i>In Progress</i></p>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 84 months (7 years) old,</li> <li>• the student receives two doses of the DTaP/DTP, DT, TD, or Tdap vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 6 months with a 1 day tolerance.</li> </ul>
<p><b>1 dose</b> <i>In Progress</i></p>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the DTaP/DTP, DT, TD, or Tdap vaccine, and</li> <li>• the difference between the last dose and effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

# Tdap

Tetanus, Diphtheria and Acellular Pertussis [Tdap] (code: Tdap)

Rule	Requirement
<b>1 dose grades 7-12</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the Tdap vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 120 months with a 4 day tolerance.</li> </ul>
<b>No dose grades 7-12</b> <i>Non-compliant</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12, and</li> <li>the student receives no doses of the Tdap vaccine.</li> </ul>

## Polio

Rule	Requirement
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Polio vaccine.
<b>Age 18+</b> <i>No Requirement</i>	Students 18 years old and older are not required to receive any doses of the Polio vaccine.
<b>1 dose Age 2-3 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months old, but no older than 3 months old,</li> <li>the student receives one dose of the IPV or combined IPV/OPV Polio vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<b>2 doses Age 4-5 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 4 months old, but no older than 5 months old,</li> <li>the student receives two doses of the IPV or combined IPV/OPV Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>

Rule	Requirement
<p><b>4 doses before 08/07/2010</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives four doses of the IPV or combined IPV/OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>• the student receives the last dose before 08/07/2010.</li> </ul>
<p><b>4 doses</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives four doses of the IPV or combined IPV/OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than 6 months with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>

<b>3 doses 4 yrs</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 48 months (4 years) old,</li> <li>the student receives three doses of the IPV or combined IPV/OPV Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>1 dose</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the IPV or combined IPV/OPV Polio vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>2 doses</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the IPV or combined IPV/OPV Polio vaccine, and</li> <li>the difference between the last dose and the effective date is less than 6 months with a 1 day tolerance.</li> </ul>

## Measles Mumps Rubella MMR

<b>Age 0-11 months</b> <i>No Requirement</i>	Students 11 month old and younger are not required to receive any doses of the MMR vaccine.
<b>1 dose PK</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: PK: Pre-kindergarten,</li> <li>the student receives one dose of the MMR or MMRV vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>1 dose 12-59 months M, M, R</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: PK: Pre-kindergarten,</li> <li>• the student receives one dose of the Measles, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives one dose of the Mumps, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives one dose of the Rubella, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul> </li> </ul>

Rule	Requirements
<p><b>2 doses K-12</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: 00: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• the student receives two doses of the Measles, MMR, or MMRV vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives two doses of the Mumps, MMR, or MMRV vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, OR</li> </ul> </li> <li>• the student receives two doses of the Rubella, MMR, or MMRV vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>◦ the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul> </li> </ul>

## Hepatitis B

Rule	Requirements
<p><b>1 dose 0-1 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 1 month old or younger, and</li> <li>• the student receives one dose of the Hepatitis B vaccine.</li> </ul>

Rule	Requirements
<b>2 doses 2-3 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 2 months, but no older than 3 months old,</li> <li>• the student receives two doses of the Hepatitis B vaccine, and</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives three doses of the Hepatitis B vaccine,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the last and the second valid dose is greater than 56 days with a 4 day tolerance,</li> <li>• the difference between the last and the first valid dose is greater than 112 days with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 168 days with a 4 day tolerance.</li> </ul>
<b>2 doses Hep B-2 Over 11 yrs</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 132 months (11 years) old,</li> <li>• the student receives two doses of the Hepatitis B - 2 dose vaccine, and</li> <li>• the difference between the second dose and the previous is greater than 4 months with a 4 day tolerance.</li> </ul>
<b>1 dose Adult Hep B-2 Over 11 yrs</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 132 months (11 years) old,</li> <li>• the student receives one dose of the Hepatitis B - 2 dose vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 4 months with a 0 (zero) day tolerance.</li> </ul>
<b>2 doses</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives two doses of the Hepatitis B vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the Hepatitis B vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Varicella

Rule	Requirements
<b>Age 0-11 months</b> <i>No Requirements</i>	Students 11 month old and younger are not required to receive any doses of the Varicella vaccine.
<b>2 doses</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 00: Kindergarten, 01, 02, 03, 04, 05, 07, 08, 09, 10, 11, 12,</li> <li>the student receives two doses of the MMRV or Varicella vaccine,</li> <li>the difference between the first dose and the students birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>1 dose</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: PK: Pre-Kindergarten, 06</li> <li>the student receives one dose of the MMRV or Varicella vaccine, and</li> <li>the difference between the first dose and the students birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>1 dose 13yo</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the MMRV or Varicella vaccine, and</li> <li>the difference between the last dose and the student's birthdate is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose &lt; 13yo</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the MMRV or Varicella vaccine, and</li> <li>the difference between the last dose and the student's birthdate is less than 3 months with a 1 day tolerance.</li> </ul>

## Meningococcal

Rule	Requirements
<b>1 dose Grades 7-12</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the Meningococcal (MCV4 or MenACWY) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 120 months with a 4 day tolerance.</li> </ul>
<b>No dose Grades 7-12</b> <i>Non-Compliant</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12, and</li> <li>the student does not receive any doses of the Meningococcal (MCV4 or MenACWY) vaccine.</li> </ul>

## Hib

Haemophilus influenza, type B [Hib] (code: Hib)

Rule	Requirements
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Hib vaccine.
<b>Age 5 years and older</b> <i>No Requirement</i>	Students 60 months (5 years) old and older are not required to receive any doses of the Hib vaccine.

Rule	Requirements
<p><b>1 dose Age 2-3 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is as least 2 months, but no older than 3 months old,</li> <li>• the student receives one dose of the Hib or the Hib 3 dose vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<p><b>2 doses Age 4-5 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is as least 4 months, but no older than 5 months old,</li> <li>• the student receives two doses of the Hib or the Hib 3 dose vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<p><b>3 doses &lt; 7 months 1st shot</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is as least 11 months old,</li> <li>• the student receives three doses of the Hib vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 6 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>

<b>1 dose</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the Hepatitis A vaccine, and</li> <li>the difference between the first dose and the effective date is less than 6 months with a 1 day tolerance.</li> </ul>

## Pneumococcal

Rule	Requirements
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.
<b>Ages 5 and older</b> <i>No Requirement</i>	Students 60 months (5 years) old and older are not required to receive any doses of the Pneumococcal PCV or PPV vaccine.
<b>1 dose required ages 2-3 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is as least 2 months, but no older than 3 months old,</li> <li>the student receives one dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<b>2 doses required age 4-5 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is as least 4 months, but no older than 5 months old,</li> <li>the student receives two doses of the Pneumococcal PCV or PPV vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>

<p><b>3 doses 6-11 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is as least 6 months, but no older than 11 months old,</li> <li>• the student receives three doses of the Pneumococcal PCV or PPV vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the second dose and the student's birthdate is less than 6 months with a 4 day tolerance.</li> </ul>

<p><b>In-Progress</b> <i>In-Progress</i></p>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the Pneumococcal PCV or PPV vaccine, and</li> <li>• the difference between the first dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
